I write in relation to the ongoing inquiry by the Joint Standing Committee on Treaties into Australia's proposed accession to the Treaty of Amity and Cooperation in Southeast Asia (the Treaty), the 1987 Protocol amending the Treaty, and the 1998 Protocol amending the Treaty.

The National Interest Analysis for the Treaty, which was tabled on 9 August, attached a status list for the Treaty and its two amending Protocols. The ASEAN Secretariat, which performs the depositary function for the Treaty on behalf of ASEAN states, subsequently has provided an updated status list for the Treaty and its two amending Protocols. A copy of that revised status list is attached.

I would be grateful if the revised status list could be accepted by the Committee as an additional submission to its inquiry into the Treaty, and included in the Committee's report on the Treaty.
