DEAR SIRs.

IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY SHOULD BE RATIFIED. AS WE ARE OF THE BELIEF THAT THIS MATTER IS ONLY OF THE CONCERN OF THE WORLDWIDE AUTOMOTIVE INDUSTRY , WE ARE AWARE THAT ALL VEHICLE MANUFACTURERS IN AUSTRALIA ARE IN FACT FOREIGN OWNED , THIS MEANS THAT ANY PARENT COMPANIES WOULD BE BOUND BY THIS TREATY , IN THE COUNTRY OF ORIGIN. ANY AUTOMOTIVE PARTS COMPANIES OWNED BY AUSTRALIA WOULD BE THEN SUBJECT TO THE ORDERS OF THOSE CLIENTS WHO MANUFACTURE THESE VEHICLES . THE EXECUTIVE DO NOT SUPPORT CONTROLS BY VARIOUS GOVERNMENTS IN RELATION TO INDUSTRY , EXCEPT FOR SAFETY , OR TO ENSURE TAXATION REGULATIONS. PARLIAMENTS INTERFERE TO MUCH IN INDUSTRIES , IT SHOULD ONLY ACT AS AN OVERSEER OF INDUSTRY NOT AS BIG BROTHER . SELF REGULATION SHOULD BE GIVEN TO INDUSTRY AS IN THIS TREATY, THE WORLD IS OVER GOVERNED BY SELF MADE EXPERTS IN PARLIAMENTS, THE LESS INVOLVEMENT BY PARLIAMENTS IN PEOPLES LIVES THE BETTER FOR THE WHOLE OF SOCIETY. 
