1. Annual Report

- 1.1 Under Section 16 of the *Public Works Committee Act 1969* (the Act), the Parliamentary Standing Committee on Public Works must table in each House of the Parliament a report of its proceedings for 1 January to 31 December for the preceding year.
- 1.2 All public works that have an estimated cost exceeding \$15 million must be referred to the Committee. Public works cannot commence until the Committee has reported on the works to Parliament and the House of Representatives resolves that it is expedient to carry out the works.¹
- 1.3 The Act states that in considering and reporting on a public work, the Committee shall have regard to:
 - The stated purpose of the work and its suitability for that purpose;
 - The necessity for, or the advisability of, carrying out the work;
 - The most effective use that can be made, in the carrying out of the work, of the monies to be expended on the work;
 - Where the work purports to be of a revenue-producing character, the amount of revenue that it may reasonably be expected to provide; and
 - The present and prospective public value of the work.²
- 1.4 During 2018, the Committee reported on 14 works. The combined cost of works approved was approximately \$1.602.8 billion. A list of the works and their individual costs is at Appendix A.

- 1.5 The Committee also requires proponent entities to notify it of proposed expenditure on public works with an estimated value of between \$2 million and \$15 million (medium works). This practice has arisen because, in the past, some proponent entities divided proposed works into several smaller components, each costing less than the referral threshold, to avoid scrutiny.
- 1.6 The Committee reviews medium works notifications to determine whether it has any concerns or objections to works proceeding. Medium works must not proceed until the Committee has given its approval.
- 1.7 In its *Eighty-First Annual Report*, the Committee reported an increase in the number of medium works submitted in 2017, largely to a change in processes at the Department of Defence.³ This increase in the number of medium works notifications has continued in 2018. A list of medium works approved by the Committee is at Appendix B.
- 1.8 In 2018, the Committee held a total of 36 meetings comprising private meetings, inspections, public and in-camera hearings. Of these meetings, 23 were in Canberra, 9 were interstate, with the remaining meetings being conducted by teleconference. A list of all Committee meetings and hearings held during 2018 is at Appendix C.
- 1.9 For referrals made after 2010, the Committee expects to receive post-implementation reports on completed projects. These reports indicate whether projects have been delivered within the advised scope, cost and timeframe. A list of all post-implementation reports received in 2018 is at Appendix D.
- 1.10 The Committee's website provides information on all past and current projects referred to it for inquiry, a regularly updated list of medium works approved by the Committee and information on project delivery for completed projects where post-implementation reports have been received.⁴
- 1.11 The Committee's website also features a copy of the Act and the *Public Works Committee Procedure Manual*. The Procedure Manual provides guidance for Australian Government entities involved in delivering public works. It presents information to help entities understand:
 - Their obligations to the Committee;
 - The information that must be provided to the Committee; and

- The Committee inquiry process.⁵
- 1.12 The Public Works Committee Procedure Manual is regularly updated to provide additional and clarifying information. In June 2018, version 9.2 of the Procedure Manual was made available on the Committee's website. Updates made in 2018 clarified the Committee's expectations for the content of medium works notifications.

Inquiries and Reports

- 1.13 The Act requires that the Committee consider and report on each referred work 'as expeditiously as practicable'. The Committee takes this very seriously and acts to ensure that referred works are scrutinised and reported on in a timely manner and without compromising the rigour of the scrutiny.
- 1.14 The standard inquiry process allows time for public comment on proposed works and opportunities for the Committee to inspect the proposed work site(s), should it wish to, prior to holding public and in-camera hearings.
- 1.15 When planning inquiry timetables, the Committee and proponent entities must consider the parliamentary sitting calendar. Generally referrals are initiated only when the House is sitting, and reports needs to be tabled in both houses of the Parliament.
- 1.16 The number of inquiries undertaken by the Committee is determined by the number of referrals it receives from the Parliament. During 2018, the Committee scrutinised 14 referrals, compared to 24 referrals in 2017 and seven referrals in the 2016 election year.
- 1.17 The Committee tabled four reports and one annual report in 2018.

Medium Works

- 1.18 The Committee must be notified of proposed public works projects with an estimated cost between \$2 million and \$15 million (excluding GST, unless GST is not recoverable). These projects are referred to as 'medium works'.
- 1.19 This is a longstanding practice of the Committee and one where the process requires proponent entities to provide less information in the notification process than that required for a full referral. The process also usually has a

- faster approval cycle but this is dependent on the Committee receiving all the necessary information up front, and on the parliamentary sitting pattern.
- 1.20 In 2018, there were 158 medium works approved with a combined value of \$854 million. In 2017, the Committee approved 147 medium works with a combined value of \$718 million and in 2016 approved 66 medium works with a combined value of \$371 million.
- 1.21 The statistics show that the increase in medium works experienced in 2017 has continued into 2018. As was the case in 2017, this is mostly due to a change in processes in the Department of Defence.
- 1.22 As noted in its *Eighty-First Annual Report*, the Committee has been actively refining its processes to address the increase in medium works notifications. This continued in 2018, with the Committee both updating its Procedure Manual and liaising with proponent entities regarding the Committee's practices.

Failure to notify medium works

- 1.23 In 2018, the Committee examined two medium works which had, at the time of notification, already been completed. One of these came from a proponent entity that had failed to notify the Committee of another medium work earlier in the 45th Parliament.
- 1.24 The Committee notes that its Procedure Manual states that all works with an estimated cost between \$2 million and the current threshold limit require Committee consideration and approval before entities seek tenders for construction.⁷ This is a long standing practice of the Committee, and entities should seek to ensure that all personnel engaged in construction projects with the potential to cost more than \$2 million are aware of this requirement.
- 1.25 In cases where entities fail to notify the Committee of medium works, the Committee will often seek a briefing on the project, and will require entities to provide details of the steps taken to ensure that all future works are notified in accordance with Committee practice.
- 1.26 The Committee has been pleased to note that several entities have made notifications for medium works, when projects were anticipated to be below the \$2 million and the resultant price was over the medium works threshold. The Committee has been able to scrutinize these notifications as part of their normal processes.

Operation Tetris

1.27 A key part of the Department of Finance National Property Efficiency Program is Operation Tetris. Tetris is focused on achieving efficiencies through 'absorbing entities' lease requirements, where feasible, into existing vacant office accommodation'.8

- 1.28 The Committee notes that Operation Tetris has achieved considerable efficiencies in 2016 and 2017. Specifically, between 2015 and 2017, more than 60,000 square metres of vacant and surplus office space in the Australian Capital Territory, and 7,000 square metres in other capital cities, had been filled under Operation Tetris. This has resulted in considerable savings to the Commonwealth, and reduced the net lettable area leased by the Commonwealth from 3.13 million square metres in 2015 to 2.89 million square metres in 2016 alone.9
- 1.29 As a part of the Committee's oversight of proposed medium works, during 2018 the Committee has had a particular focus on the extent to which entities have satisfied the requirements of Operation Tetris when considering medium works notification. In particular, in cases where entities are proposing to take up a new lease, the Committee has sought assurances that consideration of existing vacant lease space was considered before a commitment to new leased premises was made.
- 1.30 The Committee intends to continue pursuing a focus on Operation Tetris in 2019.

Engagement of Contractors

- 1.31 One of the key issues pursued by the Committee through several inquiries in 2018 has been the issue of the costs borne by the Commonwealth for engaging contractors to deliver projects on behalf of entities.
- 1.32 The two main concerns for the Committee are the additional costs incurred by the government using a head or main contractor model and the inability

of smaller local contractors to directly tender for work that is appropriate for them.

Cost of Contractors

- 1.33 The Committee examined contractor costs closely during several inquiries in 2018, and noted that the use of head or managing contractors seems to add an additional layer of cost to projects. This was particularly evident in cases where the role of these contractors was primarily to manage a series of subcontracts. The use of tier one contractors also appears to disadvantage local businesses and contractors, as it puts them in a position where they can only engage with Commonwealth construction projects as subcontractors, at best.
- 1.34 Conversely, the Committee was pleased to find that in some of the projects it examined the tender process was actually targeting tier two and tier three contractors. This facilitates greater involvement of local contractors in delivering the works, and the Committee encourages all proponent entities to continue to identify projects which are suitable for tier two and three contractors.
- 1.35 The Committee has determined that it will continue to focus on the issue of contractors in the future, as this is a key area where the Commonwealth can ensure that the opportunities presented can be of benefit to local businesses and communities.

Local Engagement of contractors

- 1.36 A related area of focus for 2018 was the use of local contractors. The Committee was interested to see to what extent the capacity of local contractors was examined during the design phase of projects, and to what extent local contractors were engaged during the construction phase of projects.
- 1.37 The Committee is concerned that, in some cases, contractors and subcontractors are being 'flown in' to undertake construction, and that local contractors are essentially being locked out of Commonwealth construction projects. While this may often be the case in remote areas where there is limited capacity to undertake construction works, the Committee will continue to focus on this area in the future to ensure that local capacity is drawn on to the greatest extent possible.

1.38 In this regard, it was encouraging to note that Defence is collecting statistics on the use of local contractors, and the Committee looks forward to seeing this information in post-implementation reports from entities in future.

Per and poly-fluoroalkyl substances (PFAS)

- 1.39 In 2018, when considering referred and medium works projects the Committee has taken an interest in how entities such as the Department of Defence and AirServices Australia are managing the impacts of per- and poly-fluoroalkyl substances (PFAS) on its bases and sites around Australia.
- 1.40 Per- and polyfluoroalkyl substances (PFAS) are a group of manufactured chemicals that have been widely used globally, since the 1950s, in the manufacture of household and industrial products that resist heat, stains, grease and water. ¹⁰
- 1.41 The Department of Defence notes:
 - Legacy firefighting foams containing perfluorooctane sulfonate (PFOS) and perfluorooctanoic acid (PFOA) as active ingredients were once used extensively worldwide and within Australia, including at Defence bases, due to their effectiveness in fighting liquid fuel fires.¹¹
- 1.42 In light of considerable community concerns the Committee has sought additional information on how the presence of PFAS is being assessed and managed within the course of referred and medium works projects.
- 1.43 The Committee notes the recent report from the inquiry into the management of per- and polyfluoroalkyl substances (PFAS) contamination in and around Defence bases by the Joint Standing Committee on Foreign Affairs, Defence and Trade.
- 1.44 The Committee will continue to seek information on the management of PFAS in projects.

Community Consultation

1.45 The Committee maintains an interest in how entities are engaging with the local community when proposing projects.

1.46 The Committee noted in Report 2/2018

The local impact of proposed public works is always an important facet of the Committee's scrutiny, and this is particularly an issue when projects take place in close proximity to residential areas.

- 1.47 In the Committee's examination of projects that are situated in the midst of urban development, the Committee considers that entities should ensure that they use a wide range of strategies to ensure that the local communities are informed of the project and have the opportunity to raise any concerns through open forums, drop in sessions and through email or a website. As well the community should have confidence that their concerns will be considered and responded to where possible.
- 1.48 The Committee encourages entities to continue to cast a wide net with their community consultation to ensure that the local community feels informed to the greatest extent possible.
- 1.49 The Committee was pleased to receive a submission from the Gallipoli Precinct Action Group Committee for the inquiry into the Chemical, Biological, Radiological and Nuclear Defence Capability Facilities Project component at Gallipoli Barracks, Enoggera, Brisbane. The group, which has a long involvement with projects at Gallipoli Barracks, commended the project team on their liaison with the group about this project.
- 1.50 In future, projects such as Defence Establishment Orchard Hills which are in an area of high future development, consideration should be given to how community consultation takes place.

Conclusion

- 1.51 The Committee considers that 2018 was another busy and productive year, and is thankful to all those who have supported its inquiries and other work during this time.
- 1.52 In particular, the Committee would like to thank the former Chair, the Hon Scott Buchholz MP, who was discharged from the Committee following his appointment as Assistant Minister for Roads and Transport in August 2018. The Committee recognises his important contribution to the work of the Committee.
- 1.53 The Committee would also like to recognise the work done by Mr Julian Hill MP during his time on the Committee.

1.54 Finally, the Committee thanks everyone who has assisted or participated in its inquiries in 2018. The Committee always appreciates the input of proponent entities, interested parties and members of the public.
