A <u>statement</u> was tabled [Letters of advice in relation to questions taken on notice are required to be tabled by not later than 10 days before the commencement of the budget estimates, supplementary budget estimates and additional estimates hearings

The Minister for Human Services (Senator Payne) tabled a <u>statement</u> relating to the 59th session of the United Nations Commission on the Status of Women [a motion to take note of the document was agreed to – <u>first speaker</u>]
