The committee met in private session on Tuesday 4 October 2016.

1. The committee resolved to present the following petitions in accordance with standing order 207:

From 1,784 petitioners—calling for the reversal of the closure of the Medicare/Centrelink office in Belmont, NSW.

From 29 petitioners—requesting the removal of the Superannuation Complaints Tribunal's powers to review death benefits.

From 1 petitioner—calling for the ratification of the Optional Protocol to the Convention Against Torture (OPCAT).

From 8,423 petitioners—requesting actions to reduce violence against women and children and provide more crisis refuges.

From 49 petitioners—calling for the recognition of Australian indigenous people in the Constitution and consultation and funding for indigenous programs.

From 73 petitioners—regarding refugee and asylum seeker processing and the resettlement and appeals system.

From 6,661 petitioners—calling for an end to the export of live animals for slaughter.

From 13,471 petitioners—calling for an immediate end to Falun Gong in China.

From 364 petitioners—calling for the closure of Manus Island and Nauru detention facilities.

Two petitions, from 110 and 102 petitioners respectively, calling for legislation for all land, companies and trusts to be at least 51 per cent Australian owned.

From 240 petitioners— calling for the introduction of a fee and dividend policy on carbon fuels.

From 6,601 petitioners—regarding persecuted Christians in the Middle East.

From 2,434 petitioners—calling for changes to legislation regarding mandatory immigration detention for children; and the release of children and their families.

From 404 petitioners—regarding the permanent residency application of the Watt family of South Gippsland, Victoria.

From 1 petitioner—regarding the citizenship of the Member for Warringah.

From 11,591 petitioners—calling for an immediate end to Falun Gong in China.

From 152 petitioners—calling for a health care card for Australians with multiple life-long chronic illnesses and rare diseases.

From the then Assistant Minister for Immigration and Border Protection—to a petition regarding permanent residency for Mr H Hunter and Ms I McCarthy.

From the Minister for Immigration and Border Protection—to a petition requesting that children and their accompanying families in immigration detention centres are placed in the community.

From the Minister for Immigration and Border Protection—to a petition requesting the House ensures monitoring of living conditions of children in detention centres.
