Dear Madam,

On 9 April last year my father passed away and later in the year my mother moved into a nursing home. Consequently over the New Year my sisters and I have had cause to review my parents' papers and finances so as to put my parents' affairs in order.

In the course of this, on 1 January 2018, I became aware of the continued existence of a family discretionary trust of which my parents had been trustees. While the trust is broadly drafted I have been advised that, unless I have actually been a beneficiary of the trust during the time I have been serving in Parliament, then I have not had a beneficial interest in the trust in that time. I can confirm that I have not been a beneficiary of the trust since being in Parliament. As such this is not a declarable interest in terms of my obligations as a Member of Parliament. However, in the interests of transparency I felt it important to make you aware of this.

As a result of this exercise my wife and I also thought it prudent to review the circumstances of her assets and family arrangements. In turn I now wish to clarify my Register of Members' Interests in two respects.

First, Avanti Investments Pty Ltd ("Avanti") is a family company of my wife's family of which she has been a shareholder. My wife's holding in Avanti is an interest which I have declared. In the last six years, the directors of the company chose to commence paying dividends each year which has given rise to an income to my wife. (My wife is not a director of Avanti and has not been involved in the decision making of Avanti.) Accordingly, I am amending my Register of Members' Interests to include Avanti as a source of income to my wife. However, each year this income has been assigned immediately to my wife's parents such that after tax there has been no benefit derived by my wife as a result of this income.

Second, my wife has invested in a blind trust called Pengana Capital Investments ("Pengana"). I have declared this investment. There is income from Pengana, but all of this income has been invested back into Pengana. (A previously declared interest of my wife in Vanguard Investments operated on the same basis. This was sold some years ago.) Accordingly, I am amending my Register of Members' Interests to include Pengana as a source of income to my wife, but the benefit to my wife as a result of this income, beyond the growth in the investment in Pengana, has been zero.

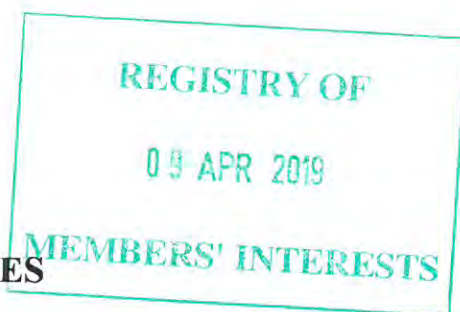
