Dear Sir,

With reference to your request regarding possession of the Dutch nationality please be advised as follows.

With regards to all the information provided and the outcome of verification at the nationality register in the Netherlands, kindly see below the explanation of your case.

1. Your father was born in the Netherlands (Amsterdam) on the 7^{th} of September 1932 and acquired Dutch nationality at birth (permitting your grandfather held Dutch nationality at the time of your father's birth).

2. You were born on the 28th of April 1959 within the marriage of your parents and therefore obtained Dutch nationality under article 1a of the then applicable Dutch Nationality Act (WNI) through your father.

3. As you have indicated you have not lived outside of Australia between 1985 and 1995 you have lost your Dutch nationality on 1 January 1995 under article 15.1.c of the then applicable Dutch Nationality Act (RWN).

4. As your name doesn't appear in the Nationality Registry you never reobtained Dutch nationality.

Therefore given the above based on the information provided regarding your ancestry and verification in the Netherlands national databases regarding nationality registrations, it is concluded that you are currently not in the possession of Dutch citizenship.
