Bills

112.01 *Senate requests amendment in place of amendment disagreed to by the House; makes further amendments*

On Monday 9 December, a message was received from the Senate returning the Commonwealth Inscribed Stock Amendment Bill 2013 and acquainting the House that the Senate, having resolved not to insist on its amendment disagreed to by the House, had requested an amendment in its place. The Senate also made further amendments for which it requested the concurrence of the House.

Standing orders were suspended to enable the Senate message to be considered immediately. Following the reporting of a message from the Governor-General, the Treasurer moved that the requested amendment be made and debate ensued. A Parliamentary Secretary moved closure of question which was agreed to on division. The question on the requested amendment was accordingly put and agreed to on division.

The House then considered the Senate's further amendments and during the debate a Parliamentary Secretary moved closure of question which was agreed to on division. The further amendments were agreed to on the voices.

112.02 *Deferred division withdrawn — Second reading amendment negatived — Fewer than five members vote on one side*

On 9 December, following the summing up of the Environment Legislation Amendment Bill 2013 by the Minister for the Environment, the Chair put the question on a second reading amendment moved earlier in the sitting by an Opposition Member. A division was called for, and in accordance with standing order 133 the division was deferred until 8 p.m. and debate was adjourned. At 8 p.m. the Chair put the question on the amendment and the Opposition Member who had moved it, requested, by leave, that the division be withdrawn. The division was withdrawn and the amendment negatived. The bill was then read a second time.

The House proceeded to consider the bill in detail and the Minister for the Environment presented a supplementary explanatory memorandum to the bill and, by leave, moved Government amendments together. When the question on the amendments was put, a division was called and, there being fewer than five Members voting with the 'noes', the Chair declared the result of the division without completing the count and the names of those in the minority were recorded in the *Votes and Proceedings*. The Australian Greens Member then moved an amendment, which was negatived on the voices. The Member moved a further amendment which, following debate, was negatived on division. The bill, as amended, was agreed to on the voices. Leave was granted for the third reading to be moved immediately and the bill was read a third time.

112.03 *Proceedings on the Infrastructure Australia Amendment Bill 2013*

On Tuesday 10 December, during resumption of debate on the second reading of the Infrastructure Australia Amendment Bill 2013, an Opposition Member was closed on division. A Minister then moved that the question on the second reading be put, which was agreed to on division. A further division was called for on the second reading, which was agreed to. As it was after 9 p.m. the Speaker proposed that the House adjourn. The Leader of the House required the question to be put immediately and the adjournment was negatived on division. The bill was then read a second time. Following the reporting of a message from the Governor-General, a Minister sought leave to move the third reading immediately, which was denied.

The Manager of Opposition Business moved that standing orders be suspended to allow him to move a motion condemning the Government for 'failing to allow proper debate' on the bill. He was closed on division, the motion was seconded and debate continued. Following several points of order, the Speaker ruled that no further points of order would be acknowledged. The Manager of Opposition Business moved that the ruling be dissented from and he and the seconder were each closed on division. The dissent motion was then negatived on division. The suspension motion was negatived on further division.

The Leader of the House, pursuant to contingent notice, moved a suspension of standing orders to enable the third reading of the bill to be moved without delay, and debate ensued. A Shadow Minister was closed on division and the Leader of the House moved that the question be put, which was agreed to on division. The suspension motion was agreed to on division and the Leader of the House moved that the bill be read a third time.

A Shadow Minister then moved that standing orders be suspended to enable him to move amendments to the bill. He and the seconder were each closed on division, and while the Leader of the House was addressing the suspension motion, a Shadow Minister moved a closure of Member which was negated on division. The suspension motion was negated on division.

The Leader of the House moved that the question on the third reading be put, which was agreed to on division. The question on the third reading was agreed to on division and the bill was read a third time. The House adjourned at 11.11 p.m.
