113.01 Fewer than five Members vote on one side

On Wednesday 12 February, when the question on the second reading of the Migration Amendment Bill 2013 was put, a division was called. Three Members (non-aligned) voted on the side of the noes. There being fewer than five Members on one side, the Chair declared the question resolved in the affirmative without completing the count and the names of those in the minority were recorded in the Votes and Proceedings.

113.02 Condolence motion for former Senator

Prior to question time on Tuesday 11 February, the Prime Minister moved a motion of condolence regarding the death of the Hon Arthur Thomas Gietzelt AO, a former Senator for NSW. The Leader of the Opposition addressed the House in support of the Prime Minister's motion. Members rose in silence as a mark of respect and debate was adjourned. The Leader of the House, by leave, moved that the resumption of debate on the condolence motion be referred to the Federation Chamber and the motion was agreed to.

The condolence motion was returned to the House on 12 February, and agreed to as all Members again rose in their places.

113.03 Statements by indulgence regarding death of former Member

Prior to question time on Tuesday 11 February, the Speaker informed the House of the death of Mr Peter Hertford Drummond, a former Member of the House for the Division of Forrest. As a mark of respect all Members present rose and stood in silence.

Following question time, the Leader of the House, by leave, moved that statements by indulgence in relation to the death of the Member be permitted in the Federation Chamber.

113.04 Statements by indulgence on the death of Ariel Sharon

Prior to question time, the Prime Minister, Leader of the Opposition and other Members, made statements by indulgence on the death of Mr Ariel Sharon. The Leader of the House, by leave, moved that statements by indulgence in relation to the death of Mr Sharon be permitted in the Federation Chamber. The question was agreed to.

113.05 Ministerial statement made during Government business time

During government business time, debate on a bill was adjourned and the Prime Minister made, by leave, a ministerial statement relating to closing the gap between Indigenous and non-Indigenous people, and presented the 6th annual Closing the Gap statement. Standing orders were then suspended to allow the Leader of the Opposition to speak in reply, and he addressed the House.

The Leader of the House moved that the House take note of the document, and debate was adjourned. The Leader of the House then declared that the resumption of debate and the motion to take note of the *Closing the Gap Prime Minister's report 2014* was referred to the Federation Chamber.

Note: Pursuant to standing order 34, ministerial statements are usually made between the end of question time and the beginning or resumption of government business each sitting day.

113.06 Attempted suspension of standing orders to enable censure motion

During question time on 12 February, the Leader of the Opposition sought leave to move a motion of censure against the Prime Minister and Treasurer. Leave was not granted and the Leader of the Opposition then moved, without notice, that standing orders be suspended to enable him to move the censure motion. Both he and the seconder were closured on division. The Leader of the House rose to speak to the motion and the Manager of Opposition Business moved a closure of question, which was agreed to on the voices. The motion to suspend standing orders was negatived on division and question time continued.

113.07 MPI terminated by motion to call on the business of the day

Following question time, the Speaker announced the matter of public importance. After the necessary support was indicated and the Member who proposed the MPI rose to speak, the Leader of the House sought the call and moved that the business of the day be called on. The motion was agreed to on division.

Note: Under standing order 46(e), at any time during the MPI discussion, any Member may move—'that the business of the day be called on'. The question is required to be put immediately and decided without amendment or debate. If agreed to, the business of the day is proceeded with immediately.

113.08 Attempted suspension of standing orders to enable motion condemning the Leader of the House

Immediately following the motion to call on the business of the day which terminated the MPI (*see* entry **113.07**), the Manager of Opposition Business sought leave to move a motion condemning the Leader of the House for shutting down debate on the MPI. Leave was not granted and the Opposition Leader then moved, without notice, that standing orders be suspended to enable him to move the motion condemning the Leader of the House. Both he and the seconder were closured on division. The Leader of the House rose to speak to the motion and the Manager of Opposition Business moved a closure of question, which was agreed to on the voices. The motion to suspend standing orders was negatived on division.

113.09 Attempted suspension of standing orders to enable motion condemning the Government

At the conclusion of an Opposition Member's contribution to the debate on the Address in Reply on 12 February, the Member sought leave to move a motion condemning the Government. Leave was not granted and the Member then moved, without notice, that standing orders be suspended to enable him to move the motion condemning the Government in relation to jobs at Gove. Both he and the seconder were closured on division. The motion to suspend standing orders was negatived on division.

113.15 Inquiry referred by Senate to Joint Standing Committee

On Tuesday 11 February, a message from the Senate was reported informing the House that the Senate had referred the Commonwealth Electoral Amendment (Above the Line Voting) Bill 2013 to the Joint Standing Committee on Electoral Matters. In addition, the Senate had resolved that the Committee have the power to consider and make use of any related evidence submitted to the Senate Finance and Public Administration Committee in relation to its inquiry into the same bill.

Note: The resolution of appointment of Joint Standing Committee on Electoral Matters requires that the Committee inquire into and report on 'such matters relating to electoral laws and practices and their administration as may be referred to it by either House of the Parliament or a Minister.'

113.16 Federation Chamber suspended due to lack of quorum

During debate on the Prime Minister's Closing the Gap Report 2014, the Chair noted that a quorum was not present, and suspended proceedings at approximately 11.03 a.m. A quorum being present at 11.27 a.m., the Chair was resumed and proceedings continued.

Note: The lapse in quorum occurred at the time Members were attending the Chamber to hear the Prime Minister's address in relation to the awarding of the 100th Victoria Cross to Corporal Cameron Baird (*see* entry **113.13**).

Standing orders

113.20 Amendments to standing orders to extend provisions for Members' 90 second statements

After acknowledgement of country and prayers on Thursday 13 February, the Leader of the House, pursuant to notice, moved amendments to standing orders 1, 34, 43 and 192. The amendments provided for a 30 minute period of Members' 90 second statements prior to question time each sitting of the House and for a 45 minute period of Members' 90 second statements in the Federation Chamber on Mondays at 4.00 p.m. The Manager of Opposition Business spoke briefly in support of the amendments, which were carried on the voices.

Note: Previously, the Order of Business provided for a 15 minute period of 90 second statements prior to question time in the House on Mondays, Wednesdays and Thursdays.
