On Monday 16 June, when the question was put on the second reading of the Migration Legislation Amendment Bill (No. 1) 2014, a division was called. Three non-aligned Members voted with the 'Noes' and in accordance with standing order 127, the Chair declared the question carried without completing the count and the names of those in the minority were recorded in the Votes and Proceedings. The Minister for Immigration and Border Protection, by leave, then moved that the bill be read a third time. The question was carried on the voices and the bill was read a third time.

In accordance with standing order 133 the division was deferred until 8.00 p.m. At 8.00 p.m. a Minister was summing up on a bill and the Chair allowed proceedings on the bill to conclude before calling on the deferred division. The House divided at 8.07 p.m. and the question on the second reading was carried on division and the bill was read a second time. The bill was then considered in detail.

The Minister presented the agreement and accompanying national interest analysis for parliament's consideration. Leave was then granted for the Minister to move a motion to suspend standing orders to enable the Deputy Leader of the Opposition to speak in reply to his statement for the same period of time. The motion was carried on the voices and the Deputy Leader of the Opposition responded.

After acknowledgement of country and prayers on Thursday 19 June, the Leader of the House, pursuant to notice, moved a motion to vary the resolution agreed to on 15 May 2014 (*see* entry **116.09**) relating to proceedings on the appropriation bills. The amendment allowed for a consideration in detail period not exceeding 15 minutes for Appropriation Bill (No. 6) 2013-2014. The Leader of the House informed Members that the original resolution had not anticipated the need to consider amendments to the appropriation bills, but the inadvertent omission of a schedule in Appropriation Bill (No. 6) 2013-2014 meant that the Government would now be seeking to move an amendment during the detail stage. On 19 June, during the second reading debate on the Asset Recycling Fund Bill 2014 (debated cognately with the Asset Recycling Fund (Consequential Amendments) Bill 2014) on 19 June, a non-aligned Member moved a second reading amendment which was seconded by another non-aligned Member. At the conclusion of the debate, the question was put on the second reading amendment and a division was called. Three non-aligned Members voted in the affirmative. As there were fewer than five Members on the side for the 'Ayes', the Chair declared the question negatived and indicated that the names of those in the minority would be recorded in the Votes and Proceedings. The Chair then put the question on the second reading and a further division was called. Three non-aligned Members voted in the negative. As there were fewer than five Members on the side for the 'Noes', the Chair declared the question carried and indicated that the names of those in the minority would be recorded in the Votes and Proceedings. The bill was then read a second time.

During Government business time on Monday 23 June, the Prime Minister, pursuant to notice, presented the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013 [No. 2] and presented explanatory memorandums to the bill and to related bills which were subsequently introduced by the Minister for the Environment. The bill was read a first time and the Prime Minister made a second reading speech. Debate was then adjourned.

118.09 *Appropriation bills returned from Federation Chamber and considered in accordance with resolution agreed to earlier*

On Monday 23 June, the Chair reported that Appropriation Bill (No. 1) 2014-2015 had been fully considered by the Federation Chamber and agreed to without amendment. The Chair then put the question that the bill be agreed to. A division was called and as only two non-aligned Members voted with the 'Noes', the Chair declared the question carried and indicated that the names of those in the minority would be recorded in the Votes and Proceedings.

The Parliamentary Secretary to the Minister for Finance, in accordance with the resolution agreed to on 15 May (*see* entry **116.09**) then moved that the bill be read a third time. A division was called and two non-aligned Members voted with the 'Noes'. The Chair declared the question resolved in the affirmative and indicated

that the names of those in the minority would be recorded in the Votes and Proceedings. The bill was then read a third time.

Appropriation Bill (No. 2) 2014-2015 was returned from the Federation Chamber and reported as having been fully considered without amendment. As with the main appropriation bill, divisions were called on the question that the bill be agreed to and on the third reading, with the same two non-aligned Members voting with the 'Noes' and having their names recorded in the Votes and Proceedings. The bill was read a third time.

Appropriation (Parliamentary Departments) Bill (No. 1) 2014-2015 was returned from the Federation Chamber and reported as having been fully considered without amendment. A division was called on the question that the bill be agreed to with the two non-aligned Members voting with the 'Noes' and having their names recorded in the Votes and Proceedings. The question on the third reading was then carried on the voices and the bill was read a third time.

Appropriation Bill (No. 5) 2014-2015 was returned from the Federation Chamber and reported as having been fully considered without amendment. The question that the bill be agreed to and the question on the third reading were each carried on the voices.

The Chair then reported that the Federation Chamber had considered Appropriation Bill (No. 6) 2014-2015 up to and including the second reading of the bill and had returned the bill to the House for further consideration.

Consideration in detail then commenced in accordance with the resolution agreed to on 15 May and amended on 19 June (*see* entry **118.05**) with the bill, by leave, taken as a whole. The Parliamentary Secretary to the Minister for Finance presented a supplementary explanatory memorandum to the bill and, by leave, moved Government amendments (1) and (2). Debate ensued, and the amendments were agreed to on the voices and the bill, as amended, was agreed to on the voices. The question on the third reading was carried on the voices and the bill was read a third time.

During Government business time on Tuesday 24 June debate resumed on the second reading of the Social Services and Other Legislation Amendment (2014 Budget Measures No. 1) Bill 2014 and the Social Services and Other Legislation Amendment (2014 Budget Measures No. 2) Bill 2014. The automatic adjournment was negated on division (*see* entry **118.32**) and after three hours of second reading debate, in accordance with the resolution agreed to earlier in the sitting (*see* entry **118.29**) the Deputy Speaker called on the Minister for Social Services to sum up. The Chair then put the question that the bills be read a second time together, which was carried on division. A message from the Governor-General recommending appropriation was announced and the bills were considered together in detail and, by leave, taken as a whole. A Shadow Minister moved a number of Opposition amendments to both bills and debate ensued. After 30 minutes, debate was interrupted in accordance with the resolution, and the Opposition's amendments were negated on division. The question that the bills be agreed to was carried on division. The Minister then moved that the bills be read a third time, and the question was carried on division. The bills were then each read a third time and the House adjourned.

During Government business time on Wednesday 25 June debate resumed on the second readings of the Public Governance, Performance and Accountability (Consequential and Transitional Provisions) Bill 2014 and three related bills. In accordance with the resolution agreed to earlier in the sitting (*see* entry **118.33**), after one hour, the Parliamentary Secretary to the Minister for Finance was called to sum up the debate. The Chair then put the question that the bills be read a

second time together, which was carried on the voices. Four messages from the Governor-General recommending appropriation were announced together and the bills were considered together in detail and, by leave, taken as a whole. A Shadow Minister moved an amendment on behalf of the Opposition and debate ensued. After 20 minutes, debate was interrupted in accordance with the resolution, and the question that the amendment be agreed to was negatived on division. The question that the bills be agreed to was carried on the voices. One question was put on the third reading of the bills together, which was carried. The bills were then read a third time.

In accordance with the resolution agreed to earlier in the sitting (*see entry 118.34*), after two hours of second reading debate, the Parliamentary Secretary to the Treasurer was called to sum up. The Chair then put the question on the second reading amendment and it was negatived on division. The question that the bills be read a second time was then carried on division. Messages from the Governor-General recommending appropriation for two of the bills were announced together and then the four bills were considered together in detail and, by leave, taken as a whole. During Government business time on 25 June, debate resumed on the second reading of the Carbon Farming Initiative Amendment Bill 2014. During the ensuing debate, a Shadow Minister moved a second reading amendment. A Parliamentary Secretary moved a closure of question which was carried on division. The second reading amendment was then negatived on division. 118.15 *Clean energy bills considered in accordance with resolution agreed to earlier; amendment to resolution agreed to; Speaker makes statement regarding Opposition amendments*

During Government business time on Thursday 26 June, debate resumed on the second readings of the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013 [No. 2] and ten related bills. The bills were called on together in accordance with the resolution agreed to on 24 June (*see entry 118.25*). Debate was adjourned and the resumption made an order of the day for a later hour. When the order of the day was called on later in the sitting, the Minister for the Environment moved an amendment to the resolution of 24 June to exclude one of the ten related bills—the Clean Energy Finance Corporation (Abolition) Bill 2014—from the resolution, and to make further consideration of that bill an order of the day for the next sitting. Debate ensued and the motion was carried on the voices.

The question that the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013 [No. 2] and nine related bills be read a second time was then put, and carried on division. Messages from the Governor-General recommending appropriation for three of the ten bills were announced together. The Speaker then made a statement to indicate that detail stage amendments foreshadowed by the Opposition had addressed her concerns that led to a previous iteration being ruled out of order on 21 November 2013 (*see entry 111.04*). The Speaker had ruled that the previous amendments did not comply with standing order 179 which provides that only a Minister may initiate a proposal to increase or extend the scope of a charge beyond that already existing under an Act of Parliament.

The ten bills were considered together in detail and, by leave, taken as a whole. A Shadow Minister moved Opposition amendments and debate ensued. The amendments were negatived on division. The question that the bills be agreed to was passed on the voices. The third reading of the bills was agreed to and the bills were then read a third time together. At 6.10 p.m. the House adjourned until Tuesday 8 July.
