Bills

6.01 Fewer than five Members vote in favour of amendments to parliamentary entitlements bills

During Government business time on 15 February, the second reading debate on the Parliamentary Entitlements Legislation Amendment Bill 2017 concluded and the bill was read a second time. Following the reporting of a message from the Governor-General recommending an appropriation for the purposes of the bill, the House then considered the bill in detail and the bill, by leave, was taken as a whole. A non-aligned Member (Ms Sharkie) moved an amendment and debate ensued. When debate concluded, the question on the amendment was put and a division was called. There being fewer than five Members voting with the "Ayes", the Speaker declared the question negatived. Consideration in detail concluded, and the question that the bill be agreed to was carried on the voices. Leave was granted for the third reading to be moved immediately and the bill was read a third time.

Later that morning, the second reading debate on the Independent Parliamentary Expenses Authority Bill 2017 (debated in cognate with a related bill) concluded and the bill was read a second time. The House then considered the bill in detail and the bill, by leave, was taken as a whole. A non-aligned Member (Ms Sharkie), by leave, moved certain amendments together and debate ensued. When debate concluded, the question on the amendments was put and a division was called. There being fewer than five Members voting with the "Ayes", the Speaker declared the question negatived. Consideration in detail concluded, and the question that the bill be agreed to was carried on the voices. Leave was granted for the third reading to be moved immediately and the bill was read a third time.

Standing order 127 provides that if, after the doors after the doors are locked, there are four or fewer Members on one side in a division, the Speaker shall declare the decision of the House immediately, without completing the count. The names of the Members who are in the minority are recorded in the Votes and Proceedings.

6.02 Closure of debate on building and construction industry bill

After the discussion of the matter of public importance on 14 February, debate resumed on the second reading of the Building and Construction Industry (Improving Productivity) Amendment Bill 2017. At approximately 7 pm, the Leader of the House moved a closure of question which was carried on division. Accordingly the Chair put the question on the

second reading which was carried on division. Leave was not granted for the third reading to be moved immediately so the Leader of the House moved a suspension of standing orders, pursuant to contingent notice, to enable the third reading to be moved without delay. The motion was carried on division. The Leader of the House then moved that the bill be read a third time. An opposition Member rose to speak to the motion and the Leader of the House moved a closure of question which was carried on division. The question that the bill be read a third time was accordingly put, and carried on division.

*After completion of the consideration in detail stage, or following agreement to the second reading if no detail stage has occurred, the House may grant leave for the motion for the third reading to be moved immediately. If leave is not granted, a Minister may move a **contingent notice** of motion to suspend standing orders to enable the third reading to be moved immediately. Contingent notices are notices conditional upon an event occurring in the House which in fact may not eventuate. In practice, the significance of the procedure is that a motion to suspend standing orders moved pursuant to a contingent notice only needs to be passed by a simple majority, whereas the same motion moved without notice would require an absolute majority.*

6.03 Leave not granted for third reading to be moved immediately, contingent notice moved and debated

At the conclusion of debate on the Native Title Amendment (Indigenous Land Use Agreements) Bill 2017, the question on the second reading was put and carried on the voices and a message from the Governor-General recommending an appropriation in connection with the bill was reported. Leave was not granted for the third reading to be moved immediately, so the Leader of the House, pursuant to contingent notice, moved a suspension of standing orders to enable the third reading to be moved without delay. Debate ensued. At the conclusion of debate, a division was called, and the suspension motion was carried on division. The Leader of the House then moved the third reading which was carried on division and the bill was read a third time.

6.04 Statements by indulgence regarding the Bourke Street tragedy; the death of Anne Deveson AO; and the 50th Anniversary of the Black Tuesday bushfires in Tasmania

Just prior to question time on 7 February, the Prime Minister and the Leader of the Opposition each made statements by indulgence in relation to the events of 20 January in the Bourke Street mall in Melbourne, in which six people were killed. As a mark of respect to the memory of the deceased, all Members present stood, in silence.

The Prime Minister and the Leader of the Opposition also each made statements by indulgence regarding the death of Ms Anne Barbara Deveson AO – an Australian writer, broadcaster, filmmaker and social commentator. As a mark of respect to the memory of the deceased, all Members present stood, in silence.

The Speaker then made a brief statement to acknowledge the 50th Anniversary of the 1967 Black Tuesday bushfires in Tasmania, which killed 64 people, injured 900 more and destroyed countless thousands of livestock, buildings, vehicles and property. The Member for Denison (Mr Wilkie), the Prime Minister and the Leader of the Opposition each made statements by indulgence on the matter.

Further statements on each matter were made in the Federation Chamber the following day.

6.13 Speaker's statement regarding Members' use of props

On three occasions during the sitting fortnight, Members displayed unusual props while addressing the House, prompting the Speaker to make a short statement on the matter.

On 9 February, the Treasurer held up a piece of coal while responding to a question without notice. On 13 February, the Member for Kennedy (Mr Katter) played traditional Aboriginal clapping sticks and then played foreign imports of the same item to illustrate the difference. During question time later that day, the Member for Melbourne (Mr Bandt), while raising a point of order, held up a solar panel. After asking the Member for Melbourne to resume his seat, the Speaker addressed the House and made the following statement:

"Last Thursday, I have to say, an undesirable prop was used here in the House, and this has occurred again today. If you look at the history of our parliamentary debate, this has occurred from time to time, but I am just giving fair warning now...this is not going to become a regular occurrence in the House. So, like a game of musical chairs, that is it. Any further repetition of it I will need to deal with. As I said, it has happened from time to time, but is not going to become a regular feature of question time."

In accordance with standing order 133, the division was deferred until after the discussion of the matter of public importance. After the MPI, the division on suspension motion was held and the question was negated.

6.19 Statement by the Speaker regarding protests on 30 November and 1 December 2016

After question time on 7 February, the Speaker made a statement regarding the disruption of proceedings in the chamber by protestors on 30 November and the display of a banner by protestors at the front of Parliament House the following day. The Speaker stated that the parliamentary departments and the Australian Federal Police were finalising a report to the Presiding Officers on the incident and would make recommendations, including those for medium and longer term implementation. The Speaker also stated that in the interim, there would be a more visible presence by the Parliamentary Security Service in the public galleries, particularly during question time. There would also be a greater presence by the AFP outside the galleries and in the Members' Hall where people obtain tickets and queue to enter the galleries. The Speaker undertook to provide additional updates as appropriate.
