20.03 Suspension of standing orders to change order of business in the Federation Chamber

During government business time on 21 May, the Minister for Citizenship and Multicultural Affairs, by leave, moved a motion to suspend standing orders to allow for a variation to the order of business in the Federation Chamber for the consideration of Appropriation Bill (No. 1) 2018-2019 and 4 related bills. The motion allowed extra Government business time to

debate the bills with changes to the meeting times, private Members' business, grievance debates and adjournment debates from Tuesday 22 May to Thursday, 28 June 2017. The motion was carried on the voices.

20.04 Personal explanation by Deputy Chair of Joint Committee of Public Accounts and Audit

During Government business time on 21 May, the Deputy Chair of the Joint Committee on Public Accounts and Audit made, by indulgence, a personal explanation regarding his statement on 8 May 2018 [see entry 19.05]. He gave the House further information he had received in regards to the draft budget estimates for the Australian National Audit Office.

As the committee responsible for parliamentary oversight of the ANAO and PBO, the Joint Committee of Public Accounts and Audit is required by legislation to consider the draft budget estimates for each office. Therefore, on Budget day each year the Committee makes a statement on whether, in its opinion, these offices have been given sufficient funding to carry out their respective mandates. See the Parliamentary Service Act 1999 regarding the Committee's role in respect of the PBO and the Public Accounts and Audit Committee Act 1951 regarding the ANAO.

On 31 May, during a Government Member's speech on the second reading debate for the Veterans' Affairs Legislation Amendment (Veteran-centric Reforms No. 2) Bill 2018, an Opposition Member drew the Deputy Speaker's attention to the state of the House. A quorum was called and formed. The Government Member then concluded his speech and sought leave to continue his remarks to make up for the time lost to the quorum call. Leave was not granted. 20.09 Resignation of Members

Following acknowledgement of country and Prayers on 21 May, the Speaker informed the House that on 11 May 2018 he had received a letter from Ms Rebekah Sharkie resigning her seat as the Member for Mayo. The Speaker also informed the House that consideration is being given to the possible dates for the by-election and he would inform the House of the dates when a decision has been made. [[Watch](#)]

Later that day, following question time, the Speaker made a statement to update the House on his consultations with the Australian Electoral Commissioner on possible dates for, by-elections for the electorates of Braddon, Fremantle, Longman, Mayo and Perth [see also item 19.09]. He outlined to the House advice from the Electoral Commissioner and the consideration by the government of urgent changes through regulation to the nomination process to ensure that candidates are aware of their obligations under section 44 of the Constitution prior to the by-elections taking place. The Speaker advised that the commissioner and a recent report by the Joint Standing Committee on Electoral Matters both support this change.

Following a point of order from the Manager of Opposition Business, the Speaker reminded the House of his obligation as Speaker when dealing with resignations and assured the Manager of Opposition Business that he will continue to consult with the commissioner and party leaders and hoped to update the House by the end of the week. 20.13 Opposition motions to suspend standing orders negated

During question time on 22 May, the Manager of Opposition Business sought leave to move a motion regarding the Prime Minister's 'secret deals'. Leave was not granted and the Manager of Opposition Business then moved to suspend standing orders to enable him to move the motion. Debate ensued and the Leader of the House moved consecutive closure motions on the mover and seconder, which was carried on division. The Leader of the House then moved a closure of question which was carried on division. The question that standing orders be suspended was accordingly put and negated on division. During Question Time on 31 May, a Government Member asked the Minister for Immigration and Border Protection a question regarding national security. Following a comment made by the Minister regarding an alleged offence, the Speaker, concerned about the comments getting into sub judice 'territory', warned the House 'in advance' to be careful about transgressing the sub judice conventions of the House. The sub judice convention states that, subject to the right of the House to legislate on any matter, matters awaiting adjudication in a court of law should not be brought forward in debate, motions or questions. This self-imposed restriction prevents the deliberations of the House and reports of its proceedings from prejudicing the course of justice.
