Bills

24.01 Bill introduced and passes all stages in one sitting

On 16 October, the Treasurer presented the Treasury Laws Amendment (Lower Taxes for Small and Medium Businesses) Bill 2018 and made a second reading speech. He then asked leave for the debate to continue. Leave was not granted and the Treasurer, pursuant to contingent notice, moved that standing orders be suspended to allow the resumption of the second reading debate to be made an order of the day for a later hour. The question was debated and carried on the voices.

The order of the day was immediately called on and the second reading debate continued until the time allocated for Members' Statements. Later, the second reading debate resumed and a number of Members spoke to the bill. The Assistant Treasurer summed up the debate and the question that the bill be read a second time was carried on the voices, with one Member (Mr Wilkie) dissenting.

By leave, the Assistant Treasurer moved the third reading immediately. A division was called and, there being fewer than five Members on the side for the 'Noes', the Deputy Speaker declared the question resolved in the affirmative without completing the count. The bill was read a third time.

24.02 Amendment moved to second reading amendment

On 24 October, debate resumed on the second reading of the Corporations Amendment (Strengthening Protections for Employee Entitlements) Bill 2018 and on an amendment to the bill moved earlier in the week by an opposition Member (Mr O'Connor). During her speech, the Centre Alliance Member (Ms Sharkie) moved an amendment to the amendment proposed by Mr O'Connor. After some debate, the debate was adjourned to a later hour.

When debate resumed, a minister summed up and the question was put on the amendment moved by Ms Sharkie to the proposed amendment moved by Mr O'Connor. There being fewer than five voting 'Aye', the Speaker declared the question resolved in the negative without completing the count. The question was then put on the second reading

amendment moved by Mr O'Connor and the amendment was negatived on division. The bill then passed through the remaining stages.

24.05 Motion to suspend standing orders regarding motion moved in the Senate

Following the acknowledgement of country and prayers on 16 October, the Manager of Opposition Business sought leave to move that the House reject a motion moved in the Senate the previous day regarding 'anti-white racism'. Leave was not granted. The Manager of Opposition Business then moved to suspend standing orders to allow him to move the motion and debate ensued.

When the time for the debate expired, the Speaker put the question. A division was called and it being during the period for deferred divisions, the division was deferred until after the matter of public importance discussion.

When the House proceeded to the deferred division, the Manager of Opposition Business asked the Speaker to re-state the question before the House, in accordance with standing order 67, and the Speaker did so. The suspension motion was negatived on division.

24.06 Statements on the death of Ian Kiernan AO

The Prime Minister and the Leader of the Opposition each made statements by indulgence, acknowledging the death of Ian Kiernan, founder of Clean Up Australia Day. On the motion of the Leader of the House, further statements were permitted in the Federation Chamber.

24.07 Motion to suspend standing orders regarding statements by minister

On 17 October, the Manager of Opposition Business moved to suspend standing orders to allow him to move that the Minister for the Environment attend and advise the House on statements she had made in the House earlier that day. Debate ensued. The House divided on the suspension motion and the numbers for the 'Ayes' and the 'Noes' were equal, 71:71.

The Speaker stated that while it was open to him to exercise his casting vote, in accordance with precedent he would simply declare the vote lost as the motion did not have the required support of an absolute majority of Members.

Usually, when the numbers are equal in a division, the Speaker will exercise his or her casting vote (in accordance with section 40 of the Constitution). However, motions for the suspension of standing orders moved without notice can only be carried by an absolute majority of Members (76 Members).

Motions

24.13 National apology to victims and survivors of institutional child sexual abuse

On 22 October, the Prime Minister moved a motion of apology to victims and survivors of institutional child sexual abuse. In accordance with a resolution of the House agreed on 20 September 2018 and pursuant to notice, the Prime Minister moved the motion at 11 am and spoke without limitation of time. The Leader of the Opposition spoke in support and all Members present stood in silence, as a mark of respect. Debate was adjourned and resumption of the debate was referred to the Federation Chamber. The sitting was then suspended at 11.44 am. [Watch]

In accordance with the resolution agreed on 20 September, the sitting was resumed at 2.30 pm and questions without notice were called on. The Prime Minister notified the House that he had consulted with the Leader of the Opposition and they had agreed that, in light of the events of the day, question time would not take place and asked that questions be placed on the Notice Paper.

The motion of apology was further debated in the Federation Chamber during the week and was returned to the House on Thursday 25 October. Later that day, the order of the day relating to the motion was called on and the question 'that the motion be agreed to' was put and carried, with all Members present again standing in silence.

24.17 Questions ruled out of order

During question time on 17 October, the Speaker ruled part of a question, relating to media commentary on leaks to the media, out of order.

Later, a shadow minister asked the Prime Minister a question regarding the activities of certain private government Members. The Speaker advised that the statements of private Members are not the responsibility of the Prime Minister and ruled the question out of order.

On 23 October, a shadow minister asked the Prime Minister a question regarding comments made by a government Member to a journalist in relation to party leadership. The Speaker ruled that the Prime Minister was not responsible for the comments of private Members and called on the next question. Later, a shadow minister asked the Prime Minister a question regarding comments made by the journalist on the matter. The Speaker ruled the question out of order.

The Member refused and the Speaker called on the next questioner.

An oral question of a strictly limited nature may be asked of a Member who is not a minister. The question must relate to a bill, motion, or other business of the House or of a committee, for which the Member asked is responsible. Questions of this kind are uncommon.
