Bills

12.01 Government order of the day discharged

During Government business time on 10 August, the Minister representing the Minister for Communications, pursuant to notice, moved that the resumption of the second reading debate of the Communications Legislation Amendment (SBS Advertising Flexibility) Bill 2017 be discharged. Debate ensued and after two Opposition speakers the question that the motion be agreed to was put and carried on the voices.

12.02 Leave denied for third reading; contingent notices moved

Twice during the fortnight leave was not granted for the third reading of a bill to be moved immediately and a suspension of standing orders, pursuant to contingent notice, was moved to enable the third reading to be moved without delay.

During government business time on 14 August, the order of the day was read for the resumption of debate on the Australian Citizenship Legislation Amendment (Strengthening the Requirements for Australian Citizenship and Other Measures) Bill 2017. The question on the second reading was put and carried on division. A Minister then sought, and was denied, leave to move the third reading. The Minister, pursuant to contingent notice, moved a suspension of standing orders to allow the motion for the third reading to be moved without delay. The question was immediately put and carried on division and the question that the bill be read a third time was accordingly put and carried on division.

On 15 August, debate resumed on the second reading debate on the Petroleum and Other Fuels Reporting (Consequential Amendments and Transitional Provisions) Bill 2017 and an amendment moved by the opposition spokesperson. The question that the amendment be agreed to was negatived on division, and the question on the second reading was put and carried on the voices. An Assistant Minister sought, and was denied, leave to move the third reading. The Assistant Minister, pursuant to contingent notice, moved for the suspension of standing orders to allow the motion for the third reading to be moved without delay. The question was immediately put and carried on division and the question that the bill be read a third time was accordingly put and carried on the voices.

12.03 Division retaken on second reading amendment

On 15 August, debate resumed on the second reading, and an amendment moved by the Manager of Opposition Business, of the Great Barrier Reef Marine Park Amendment Bill 2017. During the debate a non-aligned Member moved an amendment to the second reading amendment. At the conclusion of the debate, the question that the amendment to the amendment be agreed to was put and, a division having been called for, the division was deferred until after the matter of public importance, in accordance with standing order 133.

Following the discussion on a matter of public importance, the question, that the amendment to the second reading amendment be agreed to, was put. The House divided and, as there were fewer than five Members on the side for the 'Ayes', the Speaker declared the question resolved in the negative. A successive division immediately followed, for the second reading amendment and the bells rang for one minute. The amendment was agreed to. Due to confusion over the length of the one minute division, the Leader of the House moved for the division to be held again under standing order 132(a). The Manager of Opposition commenced debate on the motion when the Leader of the House moved that the Member be no longer heard. This motion was agreed to on division and the motion, that the House divide again was agreed to on the voices. The House then divided again on the question that the amendment be agreed to. After the bells rang for four minutes, the second reading amendment was negatived and the questions for the second and third readings of the bill were passed on the voices.

Standing order 133 stipulates that any divisions, except for divisions on a motion moved by a Minister, called for prior to 2 pm on Tuesdays, be deferred until after the matter of public importance (similarly, divisions called for between 10 am and 12 noon on Mondays, except for divisions on a motion moved by a Minister, stand deferred until after 12 noon).

If, following a division, another division is called and there no intervening debate has occurred, **standing order 131** provides for the bells to be rung for one minute instead of the usual four minutes.

Standing order 132 provides the House with the ability to divide again in certain circumstances, which include confusion, error or misadventure.

12.04 Motions to refer bills to the Federation Chamber

During government business time on 16 August a Minister, by leave, moved separate motions referring the Education and Training Legislation Repeal Bill 2017 and the Statute Update (Winter 2017) Bill 2017 to the Federation Chamber. Both questions were carried on the voices.

Standing order 45(b) allows the Leader of the House or the Chief Government Whip to make a programming declaration referring a bill to the Federation Chamber. Until 16 August, no bills had been referred via a motions since 2 December 2013.

The Leader of the House moved that further statements on each matter be permitted in the Federation Chamber, and the question was carried on the voices.

12.06 Statements by indulgence – deaths of Betty Cuthbert and Les Murray

Prior to question time on 9 August, the Prime Minister and the Leader of the Opposition each made statements by indulgence on the deaths of Elizabeth Alyse (Betty) Cuthbert AM MBE and Les James Murray AM. The Leader of the House moved that further statements on each matter be permitted in the Federation Chamber, and the question was carried on the voices.

12.07 Senate resolution reported; amendment to consider message immediately not carried

During government business time on 10 August, a message from the Senate was reported informing the House of the Senate's agreement to a resolution relating to the Murray-Darling Basin Plan. The resolution, in which the Senate requested the concurrence of the House, among other things expressed concern about allegations of theft and corruption in the management of water resources and called for the establishment of an independent national judicial inquiry into the allegations. The Leader of the House moved that consideration of the message be made an order of the day for the next sitting, to which the Manager of Opposition Business immediately moved an amendment to allow the message to be considered immediately. Following the seconder's speech the question, that the amendment be agreed, to was put and negatived on division. The question on the original motion was accordingly put and carried on division.

12.09 Ministerial statement regarding the Solomon Islands

During Government business time on 14 August, the Prime Minister made a ministerial statement relating to the conclusion of the Regional Assistance Mission to the Solomon Islands. The Leader of the Opposition then addressed the House in reply. The Leader of the House then moved, by leave, that the House take note of the document and, also by leave, that the order of the day be referred to the Federation Chamber for debate. The question on the referral of the document was passed on the voices.

Standing order 63A provides the Leader of the Opposition, or Member representing, leave to speak in reply to a Ministerial statement for an amount of time equivalent to that of the Minister who made the statement.

Later that day, during government business time, the Leader of the House moved a motion, by leave, to allow the referral of questions relating to the citizenship of the Deputy Prime Minister to the Court of Disputed Returns. Following debate the question was put and carried on the voices.

On 16 August, following prayers and acknowledgement of country, the Speaker presented documents relating to the reference to the Court of Disputed Returns.

12.17 Four attempts at suspending standing orders during consecutive question times

On all four occasions, the question, that standing orders be suspended was put, negatived on division and questions without notice then concluded.

Members again stood in their places to signify approval of the question that the motion of condolence be agreed to.
