- (1) vice **The Hon. S Conroy**, resigned 30 September 2016.
- (2) Declared elected 19 April 2017 as a Senator for South Australia by the High Court of Australia (vice **R Day**, disqualified under section 44 (v) of the Constitution, 5 April 2017) (term begun 19 April 2017).
- (3) Declared elected 2 July 2016 as a Senator for Western Australia by the High Court of Australia sitting as the Court of Disputed Returns (vice **R Culleton**, disqualified under sections 44 and 45 of the Constitution, 3 February 2017) (term deemed to have begun on 1 July 2016).
- (4) Declared elected 10 November 2017 as a Senator for Western Australia by the High Court of Australia (vice **S Ludlam**, disqualified under section 44 (i) of the Constitution, 27 October 2017) (term begun 10 November 2017).
- (5) vice **A Bartlett** declared elected 10 November 2017 as a Senator for Queensland by the High Court of Australia (vice **L Waters**, disqualified under section 44(i) of the Constitution, 27 October 2017) (term begun 10 November 2017). Resigned 27 August 2018.
- (6) vice **C Back**, resigned 31 July 2017.
- (7) Declared elected 22 December 2017 as a Senator for New South Wales by the High Court of Australia (vice **The Hon. F Nash**, disqualified under section 44 (i) of the Constitution; ruled ineligible from 2 July 2016).
- (8) Declared elected 10 November 2017 as a Senator for Queensland by the High Court of Australia (vice **M Roberts**, disqualified under section 44 (i) of the Constitution, 27 October 2017) (term begun 10 November 2017).
- (9) vice **N Xenophon**, resigned 31 October 2017.
- (10) Declared elected 9 February 2018 as a Senator for Tasmania by the High Court of Australia (vice **The Hon. S Parry**, resigned 2 November 2017) (term begun 9 February 2018).
- (11) Declared elected 9 February 2018 as a Senator for Tasmania by the High Court of Australia (vice **J Lambie**, resigned 14 November 2017) (term begun 9 February 2018).
- (12) vice **S Kakoschke-Moore**, resigned 22 November 2017.
- (13) vice **S Dastyari**, resigned 25 January 2018.
- (14) vice **The Hon. G Brandis**, resigned 7 February 2018.
- (15) vice **K Gallagher**, disqualified under section 44 (i) of the Constitution, 9 May 2018.
