## **Disability Support Pension recipients**

1. When the changes to DSP were introduced there was the main qualification criteria in s94 and there was an "alternative" qualification criteria that would not apply to anyone until at least 2 years after the introduction of the welfare to work changes.

## **Disability Support Pension recipients**

Centrelink data does not differentiate between those granted under the 'alternative' DSP qualification provision (section 94A), which allows people who were previously rejected for DSP to be granted after undertaking training activities for two years, and those granted under section 94 of the *Social Security Act 1991*.

## **Disability Support Pension recipients profile**
