Topic: PALLIATIVE CARE

Written Question on Notice

Senator Boyce asked:

Would the department please provide a breakdown of funding for subacute care for Queensland under the 2010 National Partnership Agreement; and advise how it has been allocated across the various categories – rehabilitation, palliative care, geriatric evaluation and management and psychogeriatric services.

Answer:

A breakdown of funding for subacute care in Queensland's Implementation Plan under the National Partnership Agreement on Improving Public Hospital Services (NPA IPHS) is summarised below for projects to be delivered over the period 2010-11 to 2013-14. The Plan does not include a distribution of funding between subacute care types (palliative care, rehabilitation, etc.) for all projects.

Total funding for Queensland over four years under Schedule E of the NPA IPHS: \$327 million (the total value of the projects below is taken from QLD's IP and differs slightly from QLD's allocation under Schedule E).

Palliative care

Queen Elizabeth II Hospital: 10 beds — \$12.46 million

Rehabilitation

Maryborough Hospital: 22 beds and rehabilitation facilities — \$20.38 million Cairns Hospital: 16 beds — \$14.36 million Rockhampton Hospital: 16 beds — \$22.12 million Logan Hospital: 24 beds and associated facilities — \$57.44 million Townsville Hospital: 15 beds — \$20.03 million

Support services

State-wide subacute care information management: --- \$5.56 million

Under the NPA IPHS, Queensland has the flexibility to determine the mix of subacute service types and regional distribution of beds and services that will best meet the needs of the state. In determining its needs Queensland is required to actively engage with relevant sectors in the development of its Implementation Plan and throughout the period of the NPA IPHS.
