- a) A small number of coffee machines were purchased by predecessor agencies prior to the Department's integration in July 2011 and were funded under separate agency arrangements. In the majority of cases these were purchased at the discretion of local site managers within local budgets. Detail of these machines was provided in November 2012 in response to Question on Notice HS 92. Four small machines have been purchased since the Department's integration, again at the discretion of local site managers within local budgets.
 - 1) Coffee machines were purchased for use in staff amenity areas and/or for general office catering purposes.
