#### Question:

The questions are in relation to the current and future research activity in relation to Foetal Alcohol Spectrum Disorders (FASD). (The FASD report was tabled by the Standing Committee on Social Policy and Legal Affairs Committee in the last week of Parliament 2012).

- a) What research has been funded in relation to FASD?
- b) What Funding has been committed and spent to date?
- c) Are the results of projects published, if so where?
- d) What outcomes have been identified that the department working on in relation to FASD?

#### Answer:

- a) The Department of Health and Ageing has funded a number of projects which has/have involved research into the issue of Fetal Alcohol Spectrum Disorders (FASD). This has included:
  - The Monograph Fetal Alcohol Spectrum Disorders in Australia: An Update a comprehensive report which illustrates the complex multi-faceted nature of FASD in Australia;
  - The Marulu: Lililwan Project a community driven project to determine the prevalence of FASD among children born in 2002 and 2003 in the Fitzroy Crossing Valley in the Kimberley region of Western Australia; and
  - The Australian Institute of Health and Welfare scoping study project aimed at improving data collection and reporting on FASD.
- b) The following table shows the total of committed and expended funds on projects relevant to FASD funded by the Department from 2008-09 to 2014-15.
