Question:

- a) How many documents (include the amount of copies) have been printed from Supplementary Budget Estimates in November 2013 to date? How many of these printed documents were also published online?
- b) Did the Department/agency use external printing services for any print jobs since 7 September 2013?
 - 1) If so, what companies were used?
 - 2) How were they selected?
 - 3) What was the total cost of this printing?

Answer:

- a) As printing, including documents, is not conducted centrally, to provide the answers sought would require an unreasonable diversion of resources.
- b) As printing, including documents, is not conducted centrally, to provide the answers sought for the whole department would require an unreasonable diversion of resources.
