## **Department of Social Services**

- a. From 7 September 2013 to 28 February 2014, the Department used 4 external agencies for print jobs through the Print and Promotional Products Panel and 4 external agencies off-panel.
- b. Companies used were:
  - Partech Pty Limited t/a Bytes 'n Colours
  - CanPrint Communications Pty Limited
  - New Millennium Print Pty Ltd
  - Whirlwind Print Pty Ltd
  - Paragon Printers Australasia Ltd
  - Trendsetting digital printing
  - Print Dynamics Pty Ltd
  - ADM Solutions
- c. On-panel suppliers were selected via quoting processes through the Department's Print and Promotional Products Panel. Where companies were not sourced through panel arrangements, a combination of direct sourcing and competitive selection quoting processes were used.
- d. The total cost of these print jobs was \$150,489 (GST ex).

- b. Complete Colour Printing Pty Ltd.
- c. Limited tender.
- d. The total cost of these print jobs was \$4,682 (GST ex).

# **Australian Institute of Family Studies**

- a. From 7 September 2013 to 28 February 2014, Australian Institute of Family Studies (AIFS) used 8 external services for print jobs.
- b. Companies used were:
  - Mystique
  - Print Bound
  - CanPrint Communications
  - Direct Mail and Marketing
  - Classic Colour Copying
  - Click Business Cards
  - Media Movers
  - L&R Print
- c. Printing quotes were obtained via a competitive process and in compliance with the Commonwealth Procurement Rules 2012.
- d. The total cost of these print jobs was \$24,356 (GST ex).

## **National Disability Insurance Agency**

- a. From 7 September 2013 to 28 February 2014, NDIA used external agencies for print jobs.
- b. Information on each individual item is not readily available and to attempt to provide this level of detail would involve an unreasonable diversion of Agency resources.
- c. Selection of printing firms is at the discretion of the relevant delegate. This can include quotes, panel selection or tenders, depending on the value of the procurement.
- d. The total cost of these print jobs was \$72,043 (GST ex).
