How many clients accessed services through Community Playgroups for 2011-12 through 2013-14? Please provide a breakdown by state, territory and electorate. How many Culturally and Linguistically Diverse clients accessed services through Community Playgroups for 2011-12 through 2013-14? Please provide a breakdown by state, territory and electorate. How many Aboriginal and Torres Strait Islander clients accessed services through Community Playgroups for 2011-12 through 2013-14? Please provide a breakdown by state, territory and electorate.

#### **Answer:**

Tables 1 and 2 provide a state breakdown of clients by total clients, Aboriginal and Torres Strait Islander (ATSI) and Culturally and Linguistically Diverse (CaLD) status that accessed Community Playgroups services for the financial periods 2011-12 to 2012-13.

The Department is unable to provide the 2013-14 figures at this point in time as reporting for that period is not available until 31 July 2014. The Department is also unable to provide the information by electorate as it does not collect Family Support Program data by this administrative boundary.
