Item 1: Welcome and Opening Remarks

The Chair opened the meeting at 3.30pm and welcomed members and observers to the inaugural meeting of the WPIT Expert Advisory Group (the Group). The Chair also welcomed the Minister for Human Services, the Hon Stuart Robert MP (the Minister) and Mr Mike Banham, Senior Adviser to the Minister.

Item 2 – Minister for Human Services

The Chair invited the Minister to provide the Group with an overview of the Government's objectives for the WPIT programme and his expectations for its underlying purpose, value and impact. He also asked the Minister to provide some further context on the purpose of the Group and his perspective on the areas of focus for the members.



The Minister discussed his priorities and outlined the Government's Digital Transformation Agenda and the significance of the WPIT programme as a core capability to support this. He noted that WPIT provides the foundation on which to transform the experience of Government and public services from the citizen's perspective. Getting the technology right, as well as the associated shifts in business performance and culture, was critical to achieving the Government's broader service reform and digital government priorities.

Key issues discussed included:

- WPIT is a business transformation programme first and foremost, with an IT platform as an enabler. Language and culture around the programme from the outset must reflect this.

Following Item 3, the Chair again thanked the Minister for his time and commitment and the Minister and Mr Banham then left the meeting.

Item 4 – WPIT Programme

The Secretary, Mr Shepherd and Mr Sterrenberg took EAG members through a presentation of the overview and background, as well as the current state of the WPIT Programme.

Mr Sterrenberg provided an overview of the Service Delivery Reform Programme and detailed the issues with the current systems. He noted the significant shift in customer behaviours towards digital transactions, coupled with the current complexity of design of the existing systems and multiple manual processing touchpoints, as significant drivers of the need for modernisation.

Mr Shepherd outlined for members the WPIT implementation model noting the agile, tranche based approach being taken to design and implementation. This reflects long and widespread consultation across governments and the private sector in the development of the WPIT programme and business case. Mr Shepherd reinforced the business transformation focus of the WPIT programme and the role of the technology platform as an enabler to support this.
