### Senator Joe Ludwig asked:

#### Answer:

The Department of Social Services currently has nine Boards. Each Board has provided the following responses:

# Australia's National Research Organisation for Women's Safety (ANROWS)<sup>1</sup>

- 1. Four times 23 October 2015, 20 November 2015, 18 December 2015 and 22 January 2016.
- 2. The total travel costs for the Board are \$26,885.

- 4. The Independent Chair, Ms Anne Edwards has attended all four meetings.
- 5. The 'Consent to act as a Director' form requires declaration of any conflict of interest. Rule 54 of the ANROWS Constitution prohibits a Director with a material personal interest in a matter being present or voting when the matter is discussed. Rule 55 requires a Director to advise of a conflict of interest as soon as practicable after the relevant facts are known to the Director. This must be done at a meeting or in writing to the Company Secretary. Each meeting commences with the Chair asking Directors to disclose any conflicts of interest. If a conflict arises, the relevant matters are dealt with in the absence of the Director/s for whom there is a conflict. ANROWS Board Directors are not eligible for ANROWS research grants.

- 7. The independent Chair receives a daily sitting fee \$698 (inclusive of Super).
- 8. The Constitution provides for automatic dismissal of Directors who are absent for a period of 6 consecutive calendar months without leave of absence. However, under Rule 53.1(3) of the Constitution a Director may be granted leave of absence retrospectively, if a request is made in writing via the secretary and the Board has determined to grant the leave of absence within14 days of receiving notice of the request.

The Directors' fees are paid for by NAATI which operates on government funding and income generated from conducting language tests. In the 2014-15 financial year, Commonwealth, State and Territory government funding accounted for 19.5 per cent of

NAATI's revenue (\$0.636 million or 52 per cent Commonwealth and \$0.588 million or 48 per cent from the states and territories). The remaining 80.5 per cent was sourced from fees for language testing and course accreditation. In 2015-16 the Commonwealth Government contribution to NAATI is \$0.637 million and the State/Territory commitment is \$0.590 million.
