Question:

Can you give a breakdown of organisations that have applied for funding under the 2015-16 Department of Health and Ageing Peak and Advisory Bodies Programme and that have been unsuccessful in receiving funding?

Answer:

The open competitive tender process for the Health Peak and Advisory Bodies Programme in July 2015 received 103 applications for funding.

Two applications were deemed non-compliant with tender requirements and were not assessed.

The remaining 101 applications were assessed against the following criteria:

- eligibility for funding;
- alignment of the organisation's objectives with those of the programme and the Australian Government's health agenda;
- the organisation's capacity to contribute to the objectives of the programme;
- the organisation's risk management plan;
- an outline of programme activities that the organisation will deliver and the expected outcomes of the grant funding; and
- the organisation's proposed budget.

Twenty-two applications were considered suitable for funding.

Seventy-nine applications were considered unsuitable for funding. These are listed below:
