

DEED OF VARIATION No. 3

Between the

COMMONWEALTH OF AUSTRALIA ('the Commonwealth'), as represented by the Department of Health and Ageing ('the Department') ABN 83 605 426 759

and

The Anti-Cancer Council of Victoria trading as The Cancer Council Victoria, ABN 61 426 486 15, a body incorporated under section 7 of the *Cancer Act 1958* (Vic) having its office at 615 St Kilda Road, Melbourne, Victoria, 3053 ('the Participant').

RECITALS:

- A. The parties wish to vary the agreement relating to the National Monthly Tracking Survey of Smokers and Recent Quitters dated 6 November 2012 ('the Principal Agreement').
- B. Clause 1.6 of the Principal Agreement states that no variation is binding unless it is agreed in writing between the parties.

OPERATIVE PART:

- 1. The parties vary the Principal Agreement as follows:
 - (a) At page 34 of the Schedule, under Item E. FUNDS AND INVOICE REQUIREMENTS, delete all existing text and replace with:

- 3. The Principal Agreement, as amended by this Deed of Variation, constitutes the entire agreement between the parties.


