I have gone back and had a look at the questions on notice and your evidence, Mr Bowles. Can you update the committee now? Answer:

The discussion referenced in Hansard reflects two savings measures that apply, the:

- 1. May 2014 decision *Health Flexible Funds: Pausing indexation and achieving efficiencies*, \$197.1 million over three years from 2015-16; and the
- 2. 2015-16 *Rationalising and Streamlining Health Programmes* measure, \$596.2 million over four years from 1 July 2015.

The attached table reflects the funds after these savings measures have been applied.
