Senator Di Natale asked:

Who are the members of the new National Disability Insurance Scheme Working Group? Why is there no person from a Culturally and Linguistically Diverse (CALD) background with a disability on this Working Group?

Answer:

The Government has established a National Disability Insurance Scheme (NDIS) Advisory Group to provide specialist advice on the development of the foundations for reform as well as the design of the proposed arrangements for launch of a NDIS. A list of members can be found at Attachment A.

Several NDIS engagement mechanisms have been established to ensure the views of stakeholders, including those from CALD backgrounds, are captured and fed into the design process.

The Advisory Group has met with state based NDIS/Disability Advisory groups that have included people from CALD backgrounds to discuss design and implementation elements of an NDIS.

In addition to the Advisory Group, the Government has also established four NDIS Expert Groups to advise on key design elements of the scheme. A list of members can be found at Attachment B.

Expert Group members are tasked to actively engage with their networks and the broader community to ensure a wide range of perspectives are considered. This will involve engaging with CALD organisations and individuals.

Expert Groups will be informed by the National Disability and Carer Alliance project that will engage with peaks, their members and people with disability, their families and carers at the grassroots level from right around the country on key design issues. This engagement will include targeted consultation with people from CALD backgrounds.
