4. Type of Function

Remote Service Delivery (RSD) - The Remote Service Delivery National Partnership Agreement (NPA) is a commitment by governments to work with Indigenous communities to improve the delivery of services to priority remote communities across NSW, QLD, WA, SA and NT. This NPA aims is to improve access to government services and facilities, raise the quality of these services, and better support Indigenous community governance and leadership.

Indigenous Co-ordination Centre (ICCs) are located as part of FaHCSIA Offices in urban, regional and remote areas in all States and the Northern Territory. ICCs engage with Indigenous communities, other levels of government and service providers to support initiatives that help close the gap on Indigenous disadvantage.

Longitudinal Study of Indigenous Children (LSIC) Footprints in Time: the Longitudinal Study of Indigenous Children Field officers operate from here.

National Office FaHCSIA's National Office covers a range of corporate activities, policy development, engagement with stakeholders and some service delivery.

State Office State and Territory Offices have a stronger service delivery role, and engage closely with stakeholders, including state and territory governments and non-government organisations.
