Senator CAMERON: Have you had any formal correspondence by email or letter with the department on this issue?

Mr Hutson: Yes.

Senator CAMERON: Can you table those documents.

Mr Hutson: I will take that on notice.

Mr Hutson: I would have to have a conversation with the Department of Finance, but at the moment, I will take the question on notice.

Senator CAMERON: I would ask you for all times of any telephone conversations and dates of telephone conversations. I would like all correspondence both by letter or by email from and to the Department of Finance.

Mr Hutson: Yes, I will take that on notice.

Answer:

There have been a number of informal telephone conversations between officials of the Department of Human Services and the Department of Finance since the budget announcement on 13 May 2014. Most of these conversations were of a general nature discussing administrative aspects of the scoping study and no records were kept. Details of two conversations where records were kept are at Attachment A.

There has only been email correspondence exchanged between officials of the Department of Human Services and the Department of Finance since the budget announcement on 13 May 2014. These are attached:
