#### **Question:**

Please outline the methodology for the review of voluntary alcohol labelling. Which organisations participated, were consulted or involved in this review?

#### Answer:

The evaluation was conducted by consultant Siggins Miller. The evaluation was underpinned by a rigorous methodology informed by consultations with government, industry and public health organisations.

The methodology for the review included:

- field study of outlets (i.e. label audit) to assess the extent to which pregnancy labels have been implemented by industry;
- online industry survey to assess economic impacts to industry associated with the initiative;
- online survey of consumer awareness of pregnancy labels on alcohol products;
- interviews with experts and representatives of government, public health and industry, to understand any differences between the views of public health and industry experts and to contextualise what is found through the field study of outlets; and
- a literature and document review, to understand the context within which industry was implementing the initiative, to inform the design of the consumer awareness survey, the field study of outlets and the industry study of costs, and to understand key factors impacting implementation.

The evaluation was overseen by a small reference group of government officials, chaired by the Department of Health.
