Question:

- a) Since 1 July 2014, how many DSP recipients have had their eligibility reviewed under the Budget measure affecting certain people under 35 who qualified between 2008 and 2011? Provide a breakdown under this measure by: main disability (including mental health conditions); age; gender; state and territory; with/without earnings; location (e.g. remote, capital cities, regional); marital status; receiving Rent Assistance; home-owners; country of birth.
- b) What is the cost to the Department to undertake these reviews?
- c) How many people have been have been reviewed?
- d) How many people, after the review, have been found ineligible for DSP?
- e) Provide a breakdown of the reason for the cancellation of the DSP?
- f) How many people who have had their DSP cancelled under this new measure have appealed the cancellation of the payment? Provide details of review outcomes by level of appeal. Also provide a breakdown of this data by Indigenous, non-Indigenous status.
- g) Provide data on DSP cancellations under this measure by age; state; and Indigenous/non-Indigenous status.
- h) How many people found ineligible for DSP after review are now accessing alternative social security payments? Please list by number and payment type.
- i) How many people are not receiving any income support payments?
- j) What savings have been made under this measure? How are the savings calculated?
- k) Have any people who have lost their DSP since 1 July 2014 under this measure have found employment?
- 1) Provide details of the type of employment secured and the duration of this employment.
- m) Describe the "service offer" that is provided to people whose payments are cancelled under this measure?

- n) Does the Department keep a track on whether people who are moved to a lower payment (i.e. Newstart or Youth Allowance) can afford their accommodation or their medications? Does the Department follow up to see if the person becomes homeless after being pushed onto a lower social security payment?
- o) How many people on the Newstart Allowance have a disability? Provide this data for each year over the past decade?
- p) How many people on Newstart have a partial capacity to work? Provide this data for each year over the past decade?
- q) Overall, what is the current rejection rate of people claiming the DSP? How many people have lodged a claim for the DSP since 1 July 2014? How many have been successful? Provide a breakdown of successful claims over this time frame, by main medical condition? (Number and percentages). How many claims have been rejected over this time frame (with reason for rejection), over the same time-frame?

Answer:

- a) From 1 July 2014 to 19 June 2015 the department completed 9,095 reviews under this measure. A further 11,614 reviews were in progress on 19 June 2015.
 - The following tables provide further demographic data on the completed reviews. Note:
 - The breakdown by main disability, age, gender, state and territory and location is based on a lower number of completed reviews (8,006 reviews). This is because all reviews completed are not recorded in the system as finalised for 43 days to allow for a 42 day grace period which follows cancellation for those recipients no longer eligible for payment.
 - The data relating to earnings, marital status, Rent Assistance receipt, home-ownership or country of birth can only be sourced by extracting and analysing each individual customer record. This information has not been provided due to the resources required to complete this work.

- c) From 1 July 2014 to 19 June 2015, the department completed 9,095 reviews. A further 11,614 reviews were in progress on 19 June 2015.
- d) As of 19 June 2015, there were 1,082 recipients found to be no longer eligible for Disability Support Pension (DSP) following a review.

e) Of the 1,082 recipients who were found to be ineligible for DSP, 616 recipients had their payment cancelled as at 19 June 2015. The remaining 466 recipients have payments continuing either because the recipient is in the six week grace period provided for those people whose payment is cancelled following a medical review, or because the recipient is eligible for Payment Pending Review while an appeal of the decision is in progress.

- i) As of 19 June 2015, 191 customers whose DSP was cancelled following a review were not receiving an income support payment.
- j) Questions related to savings from the measure should be directed to the Department of Social Services.
- k) The Department of Human Services does not collect this data.

m) Where a recipient is found to be no longer eligible for DSP a range of support services are offered to the customer to support them transition off the payment.

Prior to the customer being contacted regarding the outcome of the review, the department's social work team undertake an assessment of the customer circumstances to determine the level of support best suited to the individual circumstances.

The recipient is contacted by telephone to advise them of the outcome of their review and:

- Provided information about, or referrals to, government and community support services, including a referral to a social worker as appropriate.
- The department works with the recipient to determine if there is another appropriate income support payment and will streamline the transition to this payment if appropriate.
- Provided information about their rights to ask for a review of decision. If a recipient
 requests a review of the decision, they may be entitled to continue receiving DSP
 while awaiting the outcome of the review. This occurs when the grace period has
 lapsed, the review of the decision to cancel is requested within 13 weeks, and the
 recipient is not receiving another income support payment.

Information regarding the outcome of the review and rights to ask for a review of decision are also provided in a letter.

n) The Department of Human Services does not collect this data.

Anyone experiencing difficulty can contact the department for assistance. This includes social work assistance, financial counselling, weekly, advance or urgent payments; and Centrepay to help manage finances.

Further, social workers proactively make telephone contact with distressed customers, or those with identified risk factors (including becoming homeless), to ensure vulnerable people are provided with a quality and timely intervention. Social workers also provide professional support and case consultation to other staff working with these customers.

- o) The Department of Human Services does not collect this data.
- p) The table below shows the number of recipients of Newstart Allowance with a partial capacity to work (that is, recipients who, due to a medical condition, are prevented from working at least 30 hours per week at or above the relevant minimum wage independently of a program of support within the next 2 years). Data is only available from December 2010 onwards.
