Question:

Provide a list of organisations that were extended for 12 months from the 14 flexible funds that are in-scope for cuts, and if they were given indexation for that period

Answer:

All grants, including those under the Flexible Funds, are publicly reported on the Department of Health's website, in line with *Commonwealth Grant Rules and Guidelines*. This report includes the Programme the grant is funded from, the grant participant (organisation), the grant purpose and key dates, whether it is a variation, the value of the variation and the value of the grant.

Attachment A provides the list of Flexible Funds and which Programme they fall under.

The Department's relationship with funded organisations are constantly moving through the various stages of the grant lifecycle, including negotiation, variation and the ongoing management of the grant. Across the Department's more than 13,000 grants, these changes are occurring daily. The Department's grant management system is not designed to track all the stages in the grant lifecycle in a manner that would accurately address the specifics of the question. To capture the information requested would be an unreasonable diversion of resources.

Indexation is applied at a grant level and not fund level. Some organisations may have received indexation on their funding.
