**Senator Lines, Sue asked:**

For each of the following programs:

- a. Grandparents CCB
- b. Special CCB Children at Risk
- c. Special CCB Financial Hardship
- d. JETCCFA
- e. Inclusion and Professional Support Program
- f. Community Support Programme
- g. Budget Based Funded Programme

Please provide, for the last five years and the forward estimates:

- 1 - The number of families, children and services supported under each of these programs
- 2 - The annual and per capita cost for families, children and services supported under each of these programs

**Answer:**

**a. Grandparent Child Care Benefit (GCCB)**

There is no separate appropriation for GCCB. As GCCB is a special rate of Child Care Benefit (CCB), payment is made through the CCB appropriation and the Department does not separately report on this payment. Provision of this information would involve an unreasonable diversion of the Department's resources.

**b. & c. Special Child Care Benefit**

- (1) See table below for the number of children supported by SCCB for the last five years. This information is not collected for families or services. 2014-15 data is not yet available. The Department does not estimate these numbers across the forward estimates.

- (2) SCCB covers the full cost of care therefore there is no child care cost for families for the duration of their eligibility for the payment.

#### d. JETCCFA

- (1) See table below for the number of families and children assisted by the JETCCFA programme. The Department does not collect information on the number of services that are providing care to JETCCFA customers.
- (2) The Department does not collect information on the annual and per capita cost for families, children and services supported under this programme.

#### e. Inclusion and Professional Support Programme

- (1) IPSP is a service driven programme that provides support to assist eligible child care services to include children with additional needs. It does not provide direct support or funding to families and children.

The Department collects information on the number of children supported through the Inclusion Support Subsidy, noting that this is a payment for the service to engage an additional educator to support the inclusion of a child/ren with ongoing high support needs with typically developing peers.

- (2) IPSP does not require families, children or services to pay for support provided under the programme, with the exception of activities provided to services by Professional Support Coordinators (PSC). Child care services are required to pay \$11 per hour per educator to attend a training course delivered by the PSC. This is to act a disincentive for non-attendance post booking.

#### **f. Community Support Programme**

- (1) The CSP is a grant program incorporating a number of components and payment types which are tailored to support different types of child care in different locations. As the CSP is paid to child care services the Department does not keep records of the number of children or families accessing these services. The number of child care services to receive funding over the forward estimates is an estimate only, dependent on the number of services that apply and are eligible.

- (2) CSP payments are made directly to eligible child care service providers at no cost to the service, children or families for its delivery.

#### **g. Budget Based Funding Programme**

- (1) BBF is an annual grant programme for eligible child care service providers. The Department does not require funded service providers to keep a record of the number of families accessing BBF services, however, child attendance records are a requirement. The number of services and children attending in each financial year is provided in tables 7 and 8.
