Question:

What is the percentage of patients who are bulk billed for item 23 GP services - broken down into each state and territory? Please provide the most current data.

Answer:

The Department of Health does not compile statistics on patient bulk billing distributions for item 23. However, the Department does compile statistics on patient bulk billing distributions for GP non-referred attendances on a financial year basis at a national level. Item 23 represents 62.2% of all GP non-referred services and 59.6% of bulk billed GP non-referred services.
