- b) Organisations receive funding to deliver health care services across a range of areas including:
  - Primary health care;
  - Social and emotional well being;
  - Substance use;
  - Remote service delivery;
  - Child and maternal health; and/or
  - Chronic disease.
- c) Funding agreement payments are made quarterly.
- d) Payments for recurrent funding for the 2<sup>nd</sup> quarter of the 2010-11 financial year were made to Aboriginal Medical Services on 5 October 2010. Other payments, provided through competitive grants, are made in accordance with the milestones outlined in individual agreements.
