Written Question on Notice

Senator Colbeck asked:

- a) Can the Department provide the number of General Practitioners working in Tasmania, cross-referenced to local government area?
- b) Can the Department provide the number of GPs who have commenced work in Tasmania since July 1, 2010, cross-referenced to local government area?
- c) Can the Department provide the number of GPs who commenced work in Tasmania between July 1, 2009 and June 30, 2010, cross-referenced to local government area?
- d) Can the Department provide the number of GPs who discontinued work in Tasmania between July 1, 2009 and June 30, 2010, cross-referenced to local government area?
- e) Can the Department provide the number of GPs who have discontinued work in Tasmania since July 1, 2010, cross-referenced to local government area?

Answer:

a) The smallest geographical areas for which the Department publicly releases General Practitioner workforce data is by Divisions of General Practice. We have therefore provided information cross-referenced to Divisions of General Practice.
