- d) The Medicare Locals began operating under these funding agreements on the date of execution.
- e) The purpose of establishment funding provided in the initial funding agreements was to provide funds to support the establishment and initial operation of the Medicare Locals entities.
- f) The funding agreement for establishment funding was executed with the lead organisation forming the Medicare Local and supported activities such as forming a new company, setting up governance and membership arrangements, recruiting the executive team and transferring staff, assets, leases and program contracts from founding organisations to the Medicare Local entity.

The final funding agreement was executed with the Medicare Local and provides core funding to support the ongoing operational costs Medicare Locals, and to support the skills and capacity of each Medicare Local to achieve its strategic objectives.
