Answer:

Set out below is the information requested for each investment held by IBA. IBA values its portfolio annually. The amount shown is the fair value of the entire investment (not just IBA's share) as at 30 June 2012, with investments acquired after that date valued at acquisition price. Note that fair value may differ from IBA's carrying value as a result of standard accounting practices. All property investments have increased in value since purchase as well as returning strong levels of income to IBA and the Indigenous partners.
