- c) Provide a breakdown by categories of exemptions for income management, by type of exemption, by Indigenous and non-Indigenous status, in the NT.
- d) How many people are under the Vulnerable Welfare Recipient Category, by state and by Indigenous-non-Indigenous status?
- e) How many appeals in 2011-12 related to income management? What is the outcome of the appeal, by level of appeal, and by state?
