#### **Question:**

By state, broken down by indigenous and non-indigenous status in 2011-12 financial year, please provide as a total:

- a) How many member of a couple assessments were made?
- b) How many people are on partnered rates of payments?
- c) How many people are on the prison partnered rate of payment?

#### **Answer:**

- a) Member of a Couple assessments are not transactions captured by DHS systems.
- b) Partner rates of payments apply to the following payments (noting portfolio responsibility for these payments sits with: the Departments of Education, Employment and Workplace Relations; the Department of Families, Housing, Community Services and Indigenous Affairs; and the Department of Industry, Innovation, Science, Research and Tertiary Education):
  - Age Pension;
  - Carer Payment;
  - Disability Support Pension;
  - Special Benefit;
  - Wife Pension;
  - Newstart Allowance;
  - Parenting Payment Partnered;
  - Partner Allowance;
  - Sickness Allowance;
  - Youth Allowance (other);
  - Austudy Payment;
  - Youth Allowance; and
  - Youth Allowance (student).
