In the firing line

Will fire victims lose out in new scheme?



ARLIER this week NSW ← Premier Barry O'Farrell and ✓Rural Fire Service (RFS) commissioner Shane Fitzsimmons declared a state of emergency with Mr O'Farrell saying fire crews were preparing for the worst but hoping for the best.

The past week's spate of extreme fire and weather has led to the destruction of hundreds of homes in what has been described as the worst fire event in NSW in more than 40 years.

Last week Mr O'Farrell spoke with Prime Minister Tony Abbott and assured all fire affected communities that everything was being done by the State and federal governments to get urgent help to people needing assistance.

The new restrictions, announced on Monday by Minister for Justice Michael Keenan, would mean residents cut off from their homes or workplaces as a direct result of the bushfires would not be eligible for compensation under the Australian Government Disaster Recovery Payments (AGDRP), which is allocated by the Department of Human

Those ineligible to make any claims under the AGDRP could fall under the criteria of a new scheme announced by Mr Keenan and the Minister for Human Services Marise Payne on Tuesday. The new Disaster Recovery Allowance (DRA) has been made available for eligible residents in the the Blue tion.' Mountains, Lake Macquarie, Lithgow, Muswellbrook, Port Macquarie-Hastings, Port Stephens, Wyong and Wingecarribee.

have affected many individuals and have prevented people's ability to earn a living," Mr Keenan said.

He said the DRA was designed to help employees, primary producers and sole traders recover from the Recovery Payment (AGDRP) have bushfires with financial assistance for income lost due to the fires.

"It is also designed to maintain the local workforce in the disaster affected area and support longer term local and regional economic and community recovery.'

This is the first disaster event that the newly legislated payment has been provided for.

Ms Payne said the government encouraged individuals in these areas impacted by the fires to take advantage of this assistance.

Fire-affected residents may also be eligible for personal hardship and distress assistance, including a range of grants administered by most. the State government.

A spokesperson for the Attorney-General's department said in activating the AGDRP this week, the government's priority was to get early assistance to those who most needed it.

The spokesperson said the government was keeping the situation under review.

"As impacts become clearer, we will consider what broader recovery measures may be required.

However, the changes to the Australian Government Disaster prompted backlash from the federal Coalition who have labelled the move as heartless.

Shadow Attorney-General Mark Dreyfus QC questioned the decision to restrict the AGDRP for victims of the NSW bushfires without explanation or consultation.

"Mr Keenan has heartlessly removed assistance for people who have been cut off from their homes for more than 24 hours, or been without water or electricity for 48 hours," Mr Dreyfus said.

"Now is not the time for the government to be reducing assistance for NSW residents who need it
