### SITUATION REPORT 7

NEW SOUTH WALES FIRES - 17 OCTOBER 2013 AS AT 23 OCTOBER 2013 - 1300 HRS

### SITUATION

As at 1030 on Wednesday 23 October 2013 there are 59 bush and grass fire incidents across NSW of which 19 fires remain uncontained. Fires of significance include:

State Mines fire - Lithgow LGA

Mt York Road fire - Blue Mountains LGA

Linksview Rd Springwood fire - Blue Mountains LGA

Hall Road fire - Wollondilly LGA

Welfare Services staff remain on standby to staff evacuation centres and attend Emergency Operations Centres as required, noting that weather forecasts predict a deterioration of conditions throughout the day.

This Sitrep covers the Welfare Services Functional Area response to the bushfires burning in various locations.

#### IMPACT

As requested by the NSW RFS the Welfare Services Functional Area has opened 19 evacuation centres since the event began on Thursday 18 October. Currently 4 centres, including an Information and Assistance Centre at Penrith, are in operation to assist displaced residents affected by these fires. These are currently open at:

- Lithgow
- Springwood
- North Richmond
- Penrith

These centres are being managed by Family and Community Services, supported by Community Partners Red Cross, ADRA, Salvation Army and Anglicare as well as the NSW Disaster Recovery Chaplaincy Network, St John Ambulance, NSW Health – Mental Health and Save the Children.

The Ministry for Police and Emergency Services – Disaster Welfare Services team is currently managing the Penrith Panthers Assistance and Information Point to support those relocating from the Blue Mountains. This centre is being managed in conjunction with Family and Community Services and the Community Partner agencies. Currently there are large numbers of people presenting to Springwood Evacuation Centre to avoid travelling to Penrith. Centre staff have advised those affected that accommodation is being arranged from Penrith and to attend that centre if accommodation is required.

# Blue Mountains Bushfire Recovery 25 October 2013 Update

The Blue Mountains Bushfire Recovery Centre is asking for all residents that have had their property damaged or destroyed to please **call and register** at the Blue Mountains City Council on 4723 5000.

Fire & Rescue NSW Impact Assessment Teams have been undertaking assessments of the fire damaged property. Bushfires cause significant structural damage to buildings making them unstable and extremely dangerous to move around in. Wall and roof collapses can occur, as well as falling trees and branches that have been fire affected. The other risk is asbestos.

Safety is still our number one concern and it is crucial that the residents ring Council to get the information and help they need to make sure their property is safe to enter. Properties that have been assessed as posing a health and or safety risk have been clearly marked. With 210 properties destroyed and 109 damaged, it's important we inform impacted residents of the health and safety issues on their property as quickly as possible.

If you know of someone who has had their property damaged or destroyed please get them to call the Blue Mountains City Council on 4723 5000 (seven days).

# SITUATION REPORT 9

NEW SOUTH WALES FIRES - 17 OCTOBER 2013 AS AT 25 OCTOBER 2013 - 1430 HRS

### SITUATION

As at 1000 on Friday 25 October 2013 there are 58 bush and grass fire incidents across NSW of which 24 fires remain uncontained. Fires of significance include:

State Mines fire - Lithgow LGA

Mt York Road fire - Blue Mountains LGA

Linksview Rd Springwood fire - Blue Mountains LGA

Welfare Services staff remain on standby to staff evacuation centres and attend Emergency Operations Centres as required.

This Sitrep covers the Welfare Services Functional Area response to the bushfires burning in various locations.

#### IMPACT

As requested by the NSW RFS the Welfare Services Functional Area has opened 22 evacuation centres since the event began on Thursday 18 October. Currently one centre is open at North Richmond.

These centres are being managed by Family and Community Services and have been supported by Community Partners Red Cross, ADRA, Salvation Army and Anglicare as well as the NSW Disaster Recovery Chaplaincy Network, St John Ambulance, NSW Health – Mental Health and Save the Children.

FACS & MPES Welfare Services Liaison Officers are available at Emergency Operations Centres as required.

Disaster Welfare staff are present at the Recovery Centre, that opened on Tuesday, 22 October 2013 at the Presbyterian Hall, at 160 Macquarie Street, Springwood.

#### DISASTER WELFARE ASSISTANCE LINE

- Approximately 230 calls have been made to the Disaster Welfare Assistance Line since it opened on Friday
   18 October 2013. Most of these calls have been members of the public offering assistance.
- Disaster Welfare Assistance Line remains open from 8.30am till 4.30pm and is being supported by one Alumni staff member, other Disaster Welfare staff and Red Cross as appropriate.
- Based on current call volumes, this line will not be open over the weekend 26-27 October.

#### DWS DISASTER RELIEF GRANTS

- Approximately 30 applications for Disaster Relief grants have been received to date for assessment from the Blue Mountains and Central Coast bushfires.
- Approximately 60 requests for Disaster Welfare assistance have been received in total and have been referred to the Recovery Centre for follow up.

#### RESOURCES

- FACS staff, the Community Partners, Disaster Recovery Chaplaincy Network, St John Ambulance and Save
  the Children have been activated for evacuation centres. FACS staff have also supplied several staff
  members to provide a Welfare Services Liaison Officer to operations centres and assistance and information
  points as requested.
- DWS Alumni have been activated to manage the DWAL at Olympic Park and to assess needs/provide information in local communities in Springwood and at Lake Macquarie.
- The Alumni in their capacity as Disaster Welfare Officers have been interviewing approximately 20 families on average per day at the Springwood Recovery Centre.
- Save the Children are in attendance at the Springwood Recovery Centre and have supported 13 children.
   Their services provide a short term level of respite for affected families while they seek access to services in Evacuation or Recovery Centres.

- Disaster Welfare Services is meeting with local agencies in Springwood on Tuesday 29 October regarding the transition from the disaster welfare response to the broader community recovery process.
- The Disaster Recovery Chaplaincy Network has been working in Lithgow and North Richmond connecting disaster affected persons to local services. The chaplains are also in the planning phase of delivering support in the recovery phase.
