#### **Question:**

Senator SIEWERT: Who are those agents currently?

Ms Campbell: Sometimes not-for-profits, Indigenous corporations, local governments.

Senator SIEWERT: What sorts of not-for-profits?

Ms Campbell: I will see whether we can find someone to give you that detail.

Senator SIEWERT: Perhaps I could ask for that information on notice. You do not see anything wrong with giving me the organisations that do that? Would it be public information?

Ms Campbell: I think it is public information.

Senator SIEWERT: Could you provide that on notice?

Ms Campbell: Yes, we can on notice.

#### **Answer:**

As at 1 December 2013, the Department of Human Services contracted 577 third party organisations to provide access to our services in rural and remote Australia via Agents and Access Points.

The table below provides a summary of the types of organisations the department contracts to deliver these services.
