<u>HS 56</u>: With reference Additional Budget Estimates, 18 February 2012, DHS QoN HSW 6, please provide Centrelink review and appeal numbers for 2012-13 by Indigenous and non-Indigenous, income support recipient/ payment type, by state and territory, including totals, by level of appeal (i.e. Original Decision Maker, Authorised Review Officer, Social Security Appeals Tribunal and Administrative Appeals Tribunal).

Answer:

Total appeals by level:

- 135,428 requests for an internal review of a decision were received;
- 12,166 requests for review by the Social Security Appeals Tribunal (SSAT) were received;
- 1,951 requests for review by the Administrative Appeals Tribunal (AAT) were received; and
- 48 Secretary requests for review by the AAT were received.

By Indigenous and non-Indigenous:

- 11,396 Indigenous and 114,856 non-Indigenous requests for an internal review of a decision were received, and 9,176 requests were made where it is unknown whether the person was Indigenous or non-Indigenous;
- 699 Indigenous and 10,762 non-Indigenous requests for review by the SSAT were received, and 705 requests were made where it is unknown whether the person was Indigenous or non-Indigenous;
- 52 Indigenous and 1,808 non-Indigenous customer requests for review by the AAT were received, and 91 were made where it is unknown whether the person was indigenous or non-Indigenous; and

- <20 Indigenous and 33 non-Indigenous Secretary requests for review by the AAT were received, and <20 requests were made where it is unknown whether the person was Indigenous or non-Indigenous.*
