### **Question:**

For 2012-13:

- a) How many claims for Crisis Payment were successful?
- b) How many claims for Crisis Payment were rejected?
- c) How many claims for Crisis Payment were made?
- d) At November 2013, provide a breakdown of Crisis Payment recipients by payment type, gender, age, reason for grant, Indigenous/non-Indigenous status, and state and territory of recipient.
- e) What was the cost of outlays on Crisis Payment for 2012-13?

#### **Answer:**

- a) For 2012-13, 60,855 applications for Crisis Payment were successful.
- b) For 2012-13, 3,946 applications for Crisis Payment were rejected.
- c) For 2012-13, 64,801 claims for Crisis Payment were made, of which 60,855 were successful and 3,946 were unsuccessful.
- d) For the period 1 July 2013 to 30 November 2013, the breakdown of Crisis Payment recipients is shown in the tables below.
