Question:

- d) Provide details of a breakdown of how many rejections were appealed, to each level of review and the outcome of the appeals.

Answer:

- a) In 2013-14, there were 32,652 claims lodged for the Unreasonable to Live at Home Allowance.
- b) In 2013-14, there were 10,522 claims for the Unreasonable to Live at Home Allowance rejected.
