Since Budget Estimates in June, 2014:

- 6. How many payments owed (as a number and as a percentage of the total) have been paid in over 120 days?
- 7. For accounts not paid within 30 days, is interest being paid on overdue amounts and if so how much has been paid by the portfolio/department agency since Estimates, 2014?
- 8. Where interest is being paid, what rate of interest is being paid and how is this rate determined?

Answer:

<u>Department of Social Services (including the Aged Care Commissioner, the Aged Care Pricing Commissioner and the Social Security Appeals Tribunal):</u>

For the period 6 June 2014 to 31 August 2014:

- 1. The average time was 22 days.
- 2. 5,114 (94.5 per cent)
- 3. 217 (4.0 per cent)
- 4. 32 (0.6 per cent)
- 5. 20 (0.4 per cent)
- 6. 30 (0.5 per cent)
- 7. Yes, interest is paid to small businesses when the invoice is paid late as per Finance Circular 2012/02 and Resource Management Instruction 417/2014. Since 6 June 2014, \$733.72 in interest has been paid.
- 8. Interest is calculated by using the General Interest Charge rates as per guidance provided by the Australian Taxation Office.
