- 2. The Ministers' and Parliamentary Secretary's offices costs are managed by the Department of Finance (Finance) and therefore this question should be directed to Finance.
- 3. The Department does not entertain. Costs for official hospitality are provided in the response to question one (1) above.
- 4. The Ministers' and Parliamentary Secretary's offices costs are managed by Finance and therefore this question should be directed to Finance.
- 5. Official hospitality is used for business purposes, when required and may include expenditure on planned events across Australia to recognise important and significant dates such as:
 - Australia Day Awards
 - National Families Week
 - Seniors Week
 - Mental Health Week
 - International Day for People with Disability
 - White Ribbon Day
 - Donate Life Week
 - Carers Week

The level of detailed event information requested is not readily available for the Department. To identify this information would require a significant diversion of resources.
