Topic: Ministry MYEFO

Senator Bilyk, Catriona asked:

- 1. How much funding was cut from the Ministry in MYEFO? Which programs will have to be discontinued or reduced? Please provide the details for each.
- 2. By how much will funding for each National Cultural Institution be reduced? What advice has the Ministry received from each NCI about the reduction or cessation of services that will now be necessary?
- 3. What advice has the Ministry provided to the Minister about the effects of the MYEFO cuts on the programs and services of each National Cultural Institution?

Answer:

- 1. The Ministry for the Arts' administered funding will decrease by \$9.6m over the four years from 2015-16 to 2018-19. The reduction in funding comprises:
 - \$6.0m over three years from 2015-16 to 2017-18 for ceasing the Book Council of Australia; and
 - \$3.6m over four years from 2015-16 to 2018-19 from uncommitted funds across various programmes.

In addition to the above, the Ministry for the Arts' departmental funding will decrease by \$2.0m over four years from 2015-16 to 2018-19.
